ALDA Membership Options

On behalf of the Association of Late-Deafened Adults (ALDA), and those we serve, thank you for your membership! Your annual and/or lifetime membership supports hearing loss outreach including, but not limited to, legal advocacy, public support and educational/outreach, the *ALDA News* newsletters, virtual and in-person workshops, in-person annual ALDA Convention, and other resources designed to connect with and support people dealing with hearing loss and hearing allies.

In addition, you have the option to select national membership or dual membership (national + local chapter or group) with this form.

All current members receive member-only pricing when registering to attend our annual ALDA convention.

Regular Membership: For regular members under 62 years of age per individual. \$30.00 per person/year.

Dual Chapter or Group Membership: For individual ALDA Chapter or Group members who join both locally and ALDA nationally. Each individual under age 62 receives a \$5.00 discount off the regular membership rate: \$25.00 per person/year.

Senior Membership: For individuals over 62 years of age: \$25.00 per person/year.

Veteran Membership: For all Veterans: \$25.00 per person/year.

Business Membership: For all Businesses/Organizations: \$50.00 for each business employee and/or Business/Organization per year.
