#### How we use your personal information

We will only use your personal information for the following purposes:

- To administer and manage our relationship with you, including to set up and maintain any order of works that we are to be carrying out for you or purchasing for you on your behalf.
- To process orders from you for goods and services.
- To deal with any enquiries we receive from you.
- For the purposes of any corrective action (including a product recall) which may be required in respect of any of the products we supply you.
- To comply with applicable laws, regulations and rules.
- To provide you with details of our products, services and promotions.
- To notify you of any changes to what we do.
- · To make checks of credit reference agencies if needed.
- For the purpose of recovery of a debt in case of non-payment.

In connection with these purposes, we may share your personal information with third parties that perform services on our behalf, such as business partner, fraud sharing organisations and to other companies in our group, in each case within the European Economic Area and the U.K.

We may also disclose your personal information to third parties in other circumstances, in particular:

- If we are under a duty to disclose or share your personal information to comply with any legal obligation, or to enforce or apply our terms and conditions of trading and other agreements.
- To protect the rights, property, or safety of The Lifecare Centre LTD, Rosewood Installations, our staff, our customers or others.
- In response to a request from the governmental authority (including a regulator); or
- If we sell or buy any business or assets, in case we will disclose your personal information to the prospective seller or buyer of such business or assets.

If necessary for debt recovery purposes, we may also obtain additional information about you beyond that provided by your selves from credit reference and tracing agents.

Our legal basis for these uses of your personal information may include that (a) it is necessary for our legitimate interests in operating our business and/or providing you with goods and services; and/or (b) it is necessary for the performance of contracts to which you are a party with us.
