## 1. Your Acceptance of this Agreement.

This is an agreement between you and Diamond Freight Logistics and governs your use of the Site, its contents and services. Freight Logistics-related or Diamond Freight Logistics Affiliate-related business, for no other purpose, and not to compete with Diamond Freight Logistics or Diamond Freight Logistics Affiliates. Upon Diamond Freight Logistics request, you will immediately return or destroy all such Diamond Freight Logistics confidential information in your possession and make no further use thereof.

# 10. Third Party Products and Services.

From time to time, the Site may contain information about third party products and services.
