This package explains the official rules under the Ontario Municipal Elections Act, 1996, how to contribute by cheque or e-transfer, and the contribution form to include with your support. All contributions are governed by provincial law and will be reported as required.

### AT A GLANCE

- Maximum contribution to Sam Sinjari: \$1,200 per individual contributor.
- Maximum total to all Lakeshore Council candidates combined: \$5,000 per contributor.
- Who can contribute: Any individual resident of Ontario. Corporations and unions cannot contribute.
- How to contribute: Cheque payable to Sam Sinjari, or e-transfer to info@votesam.ca.
- Note: Municipal campaign contributions are not tax deductible.

## PLEASE READ BEFORE CONTRIBUTING

### WHO CAN CONTRIBUTE

Any individual who is a resident of Ontario may contribute to a candidate's campaign. You do not need to live in Lakeshore to contribute to Sam Sinjari, as long as you are an Ontario resident.

### WHO CANNOT CONTRIBUTE

Corporations carrying on business in Ontario, trade unions, and other entities such as neighbourhood associations, clubs, or professional associations are NOT permitted to contribute to a candidate. Members may contribute individually. Federal and provincial political parties and constituency associations are also not permitted to contribute.

### MAXIMUM CONTRIBUTION TO ONE CANDIDATE

You may contribute a maximum of \$1,200 to Sam Sinjari's campaign. This includes the value of any goods or services donated.

### MAXIMUM CONTRIBUTION TO ALL LAKESHORE CANDIDATES

You may not contribute more than \$5,000 in total to all candidates running for offices on Lakeshore Council combined.

### CASH LIMIT

Only contributions of \$25 or less may be made in cash. Any contribution above \$25 must be made by cheque, money order, or a traceable electronic method such as an e-transfer that clearly shows where the funds came from.

### CONTRIBUTIONS MUST COME DIRECTLY FROM YOU

You cannot pool money from others and forward it as a single contribution. If a contribution is made from a joint account, it must be clear which person is making the contribution.

### NAME AND ADDRESS REQUIRED

If your total contributions exceed \$100, your name and address will be recorded on the campaign's public financial statement as required by law. The campaign will keep a record of every contributor regardless of amount.

### ANONYMOUS CONTRIBUTIONS NOT ACCEPTED

Anonymous contributions are not permitted. The only exception is cash donations of \$25 or less received at a fundraising event.

### NOT TAX DEDUCTIBLE

Contributions to municipal council campaigns in Ontario are NOT tax deductible and cannot be credited against federal or provincial income taxes.

### REBATE PROGRAM

Some Ontario municipalities offer a contribution rebate program. If a rebate program applies in Lakeshore for the 2026 election, details can be confirmed by contacting the Lakeshore Municipal Clerk at [elections@lakeshore.ca](mailto:elections@lakeshore.ca).

### CAMPAIGN PERIOD

The campaign period begins on the day the Clerk receives the candidate's nomination filing. Contributions may only be accepted during the campaign period. The Lakeshore 2026 nomination period opens May 1, 2026 and closes August 21, 2026.

### PUBLIC REPORTING

All campaigns must file a financial statement with the Municipal Clerk. The financial statement is a public document and lists all contributors who give more than \$100 in total.

*Note: All contributions over \$25 must be by cheque, money order, or traceable electronic transfer. Cash contributions over \$25 cannot be accepted. The campaign will issue you a contribution receipt (this is not a tax receipt). Contributor name and address are required by the Ontario Municipal Elections Act, 1996 for all contributions over \$100 and will appear on the campaign's public financial statement.*
