

# 9<sup>th</sup> Edition Resources

Building permit applications for projects utilizing eighth edition code provisions will need to be filed on or before December 31, 2017. Applications received after January 1, 2018, where the project has been designed to the eighth edition, shall be returned to the applicant. The applicant will either need to revise construction documents and specifications to comply with ninth edition standards or seek relief through the [Building Code Appeals Board](#) (BCAB).

The new, ninth edition code is based on modified versions of the following 2015 International Codes as published by the International Code Council (ICC).

We are aware of the issue and are working to correct. Please pardon the inconvenience.)*
