Bed & Bone Boarding Agreement

This is a contract between *Beck and Call Services, LLC* (hereinafter called *Beck & Call/Bed & Bone Experience*) and the pet owner whose signature appears below (hereinafter called "Owner" for services for _____ hereinafter called "Pet(s)"). Owner agrees to pay 50% of boarding fee when Pet(s) is/are checked into *Bed & Bone boarding* as posted on the rate sheet given to owner. Pets picked up after 12:00 noon will be charged the full *Bed & Bone* boarding rate for that day. Owner agrees to pay all costs and charges for special services requested, plus all veterinary expenses deemed appropriate by *Beck & Call* for Pet(s) during the time it is in our care. *Beck and Call* shall attempt to contact Owner before incurring such veterinary services as may be required by Pet's health and/or behavior.

Due to the social nature of *Beck and Call/Bed & Bone Experience*, inherent risks may occur. These risks may include, but are not limited to, transfer of communicable diseases such as canine cough. Injuries may include, but are not limited to, broken nails, sore feet, puncture wounds, abrasions and cuts. These injuries are can usually be managed by our staff or at home. In some cases, veterinary care may be required.

Beck & Call shall exercise reasonable care for Pet(s) delivered by Owner to *Beck and Call* for *Bed & Bone Boarding*. It is expressly agreed by Owner and *Beck and Call* that *Beck & Call's* liability shall in no event exceed fair market value for the Pet(s) boarded. The Owner agrees to be financially responsible for any *Beck & Call* property damaged by Pet(s). Reasonable costs for damage will be payable upon checkout of Pet(s).

Owner specifically represents documentation to *Beck and Call* that Pet(s) has/have not been exposed to rabies or distemper within a thirty-day period prior to boarding. *Beck and Call* requires a copy of the proof of current Rabies and Bobadilla (within 6 months). Pet(s) will be checked for external parasites (fleas/ticks) upon entry to *Beck and Call*. If any external parasites are found Pet(s) will be treated accordingly and the Owner will be responsible for expenses.

If Pet(s) becomes ill or if behavior is endangering itself, humans, or other animals, *Beck and Call*, in its sole discretion, may engage the services of a veterinarian. All attempts will be made to contact the Owner of Pet(s) first; however, in the event of an extreme emergency, the well-being of the Pet(s) will come first. Medication will be administered as necessary under the direction of the veterinarian. The undersigned Owner hereby gives the veterinarian complete authority to treat Pet(s) in the manor deemed necessary. Owner will be responsible for all veterinary charges upon release of Pet(s). Owner also gives full authority for the treating veterinarian and their associated to discuss with *Beck and Call* any aspect of nay illness or injury that *Beck & Call* has presented for treatment.

Owner authorizes *Beck and Call* to use pictures of his/her pet(s) taken while at *Beck & Call* for use on its website and in other promotional materials.

By signing this agreement and leaving your pet(s) with *Beck and Call/Bed & Bone Experience*, Owner certifies to the accuracy of all information given about Pet(s) to the best of his/her knowledge. Owner specifically represents that he or she is the sole owner of said Pet(s).

By signing this agreement, Owner indicates that he or she has read and accepted all policies listed in this agreement as well as all policies for *Beck and Call's/Bed & Bone Experience* Schedule of Services and Fees.

This contract contains the entire agreement between the parties.
