Basic Conditions Statement Rev G

Introduction

The Coldean Neighbourhood Plan can only be put to a referendum and be made if it meets the 'basic conditions' set out in Paragraph 8(2) of Schedule 4B to the Town and Country Planning Act 1990. The 'basic conditions' are as follows:

- (a) having regard to national policies and advice contained in guidance issued by the Secretary of State it is appropriate to make the order (or neighbourhood plan).
- (b) having special regard to the desirability of preserving any listed building or its setting or any features of special architectural or historic interest that it possesses, it is appropriate to make the order. This applies only to Orders.
- (c) having special regard to the desirability of preserving or enhancing the character or appearance of any conservation area, it is appropriate to make the order. This applies only to Orders.
- (d) the making of the order (or neighbourhood plan) contributes to the achievement of sustainable development.
- (e) the making of the order (or neighbourhood plan) is in general conformity with the strategic policies contained in the development plan for the area of the authority (or any part of that area).
- (f) the making of the order (or neighbourhood plan) does not breach, and is otherwise compatible with, EU obligations.
- (g) prescribed conditions are met in relation to the Order (or plan) and prescribed matters have been complied with in connection with the proposal for the order (or neighbourhood plan).

This statement is to be read in conjunction with the Coldean Neighbourhood Plan which provides a development plan for Coldean to 2030. It sits alongside the Brighton and Hove City Plan Part I and Part II as well as the National Planning Policy Framework. The Coldean Neighbourhood Planning Forum has brought residents together to develop this Neighbourhood Plan to protect what we have and embolden inspiring planning designs to move us forward into becoming a more attractive village. In the Plan we have Design Codes that reflect what should be in a village, a Master Planning Framework that suggests improvements covering our shopping areas: the Plan protects our open green spaces and sets out many more policies that local residents asked us to address.

Our Vision, 'to remain a residential suburb of Brighton as a family friendly community with uninterrupted connection to Stanmer Park, the Wild Park and Highfields' - Coldean Neighbourhood Planning Forum.

Compliance

- As per the addendums to the Basic Conditions Statement, the Coldean Neighbourhood Forum and the Coldean Neighbourhood Area was designated by Brighton & Hove City Council through a decision made by the Tourism, Equalities, Communities & Culture (TECC) Committee on 25 November 2021.
- This Basic Conditions Statement supports the Coldean Neighbourhood Plan.
- The Coldean Neighbourhood Plan clovers the period from 2021-2030.
- The Coldean Neighbourhood Plan does not relate to more than one neighbourhood area.
- The Plan does not contain any policies which relate to excluded development as defined by section 61K of the Town and Country Planning Act 1990.

Consultation

During the period since the Coldean Neighbourhood Planning Forum was approved there have been 3 AGMs, 2 Vision and Objectives Meetings and 9 Forum Open Meetings, 34 emailed Updates to Forum members, and Consultees. A regularly maintained dedicated website and Facebook page have also been set up. There have been numerous surveys, subgroup meetings, forum committee meetings, consultations, consultation launch meetings, hard copies of documents made available for review in the Coldean Library and in local shops, informal discussions and formal discussions with other parties - i.e., the Local Planning Authority and the South Down's National Planning Authority. In addition, MP Sian Berry, other Elected Councillors, AECOM, Locality and Groundworks (Grants), have been informed of the development of the Coldean Neighbourhood Plan. Basic Condition (d)

The Neighbourhood Plan's policies have also been assessed against the three overarching objectives considered in achieving sustainable development as identified in the NPPF:

- an economic objective to help build a strong, responsive and competitive economy, by ensuring that sufficient land of the right types is available in the right places and at the right time to support growth, innovation and improved productivity; and by identifying and coordinating the provision of infrastructure;
- a social objective to support strong, vibrant and healthy communities, by ensuring that a sufficient number and range of homes can be provided to meet the needs of present and future generations; and by fostering a well-designed and safe built environment, with accessible services and open spaces that reflect current and future needs and support communities' health, social and cultural well-being; and
- an environmental objective to contribute to protecting and enhancing our natural, built and historic environment; including making effective use of land, helping to improve biodiversity, using natural resources prudently, minimising waste and pollution, and mitigating and adapting to climate change, including moving to a low carbon economy.

The Coldean Neighbourhood Plan is focused on sustainable development, and this will be encouraged and achieved with community led approaches. Balancing environmental protection, social wellbeing and economic vitality, which are encouraged with tailored policies that direct local needs. Designated green spaces included within the Coldean Neighbourhood Plan identify and protect local green infrastructure, which is supported with sustainable design standards which promote eco-friendly building practices local materiality and renewable technologies, as well as incorporate biodiversity net gain principles. The transport policies prioritise safe, direct routes for walking and cycling, whilst reducing car dependency. The protection of allotments will also promote local food production. The Coldean Neighbourhood Plan will also encourage monitoring sustainability outcomes, and regular reviews / updates to respond to climate changes.

Basic Condition (e)

The making of the order (or neighbourhood plan) is in general conformity with the strategic policies contained in the development plan for the area of the authority (or any part of that area).

The Coldean Neighbourhood Plan reflects the local planning policies of the Brighton & Hove City Plan Part 01 and 02 and the South Downs National Park Local Plan as the Coldean Neighbourhood Area lies within both the Brighton & Hove and the South Downs National Park's boundaries and is therefore required to conform to both sets of strategic policies.

By embedding biodiversity into the planning and design process, the Coldean policy ensures development contributes positively to the natural environment and supports the wider goals of ecological connectivity and climate resilience.

Overview of Conformity

The Neighbourhood Plan includes a vision which does not conflict with the overarching vision and objectives contained in the adopted Local Plan. Policy wording has been chosen with the aim of being clear and unambiguous, but at the same time recognising that there needs to be flexibility. There are no obvious conformity issues raised by these policies. The policies are not intended to be prescriptive, and focus on reinforcing local distinctiveness.

Basic Condition (f)

The 'making' of the Neighbourhood Plan must not breach or conflict, and must be compatible, with EU obligations, must not have a significant effect on a European site, and must contribute to the achievement of sustainable development. It must not breach human rights, within the meaning of the Human Rights Act 1998.

EU Obligations

The making of the Coldean Neighbourhood Plan does not breach, and is otherwise compatible with, retained EU obligations.

The Coldean Neighbourhood Plan has been prepared in accordance with the requirements of the Human Rights Act 1998. In particular, it has had regard to the rights contained in the European Convention on Human Rights (ECHR) and ensures that the plan is compatible with these rights. The plan-making process has been inclusive and transparent, with multiple opportunities for community engagement, including public consultations and local workshops. All sections of the community, including protected groups under the Equality Act 2010, were able to participate. The policies within the plan do not discriminate against any individual or group. Instead, they seek to promote inclusion, community cohesion, and equality of opportunity across the neighbourhood.

In accordance with the retained provisions of EU law (following the UK's departure from the European Union), the plan has been assessed to ensure compliance with environmental protection obligations, including the need for a Strategic Environmental Assessment (SEA). A screening opinion was requested from Brighton & Hove Council to determine whether the plan would require a Strategic Environmental Assessment under the Environmental Assessment of Plans and Programmes Regulations 2004 (as retained EU law). A Habitats Regulations Assessment screening was also undertaken to determine whether the plan is likely to have significant effects on any European designated sites under the Conservation of Habitats and Species Regulations 2017 (as retained).

Strategic Environment Assessment (SEA) and Habitats Regulations Assessment (HRA)

The Coldean Neighbourhood Planning Forum carried out a screening assessment of the pre-submission version of the Coldean Neighbourhood Plan to determine whether a full SEA or HRA was required. This assessment, which included consultation with the statutory agencies, confirmed that it is unlikely that there will be any significant environmental effects arising from policies in the pre-submission. As a result, they have confirmed that a full SEA or HRA are not required. Whilst the submitted Coldean Neighbourhood Plan contains amendments in response to the Statutory Regulation 14 consultation, these amendments do not materially affect this conclusion.


