1. Maximum of 12 contestants

- a) Entry fee is \$10 per person
- b) Applications are accepted on a first-come, first-serve basis. The first 12 applications received will be in the Nowicki's Brat Eating contest, all others will be placed on a waiting list. This completed form and \$10 entry fee are required to hold your place.
- c) Proof of identification is required before or on the day of the event. Must be 18 to enter.
- d) Contestant must sign this waiver form.
- e) All contestants will receive a "Nowicki's Sausage Shoppe T-shirt" (sizes limited to Large & X-Large)
- f) Past winners of Nowicki's Sausage Brat Eating Contests **are eligible** for this contest.

2. Contest Starts at 2:00 pm on Saturday August 15th, 2026 @ The Big Tent, Lakeside Park, Rogers City, Michigan

- a) 1:00 pm to 1:30 pm - All pre-registered contestants must check-in at Nowicki's Sausage Shoppe booth inside BIG TENT.
 - b) 1:30 pm - If any of the 12 pre-registered contestants not checked-in, then people on waiting list will be eligible to participate.
 - c) 2:00 pm - The contest rules meeting begins and the 12 contestants are announced at the eating site.
 - d) Entry fees are non-refundable. First 12 will pay to hold your spot. People on waiting list bring \$10 to event just in case a spot opens.
