- HWPA dues are \$75 year. There are about 190 properties in the Hogan/Whitney Ponds watershed. About 1/3 of these property owners pay dues on annual basis

VI. Open issues

a) Dam (grade control) status (Adam Garland, Oxford TM)

• Adam was unable to attend the meeting but provided the following report for the grade control progress. In summary, progress is being made but has been slowed down by additional requirements for awarded grants. Summer of 2024 is expected start date.

Town Manager Report:

- The Town continues to work with VHB Engineering on the grade control projects.
- Engineering/design has been completed for the grade controls and access road portion of the project.

- Bids packages have been prepared by VHB for the project
- The Town has secured access to the site of the grade controls
- All State level reviews have been completed
 - o MDEP
 - Archaeological fact find/review
- Army Corp of Engineer reviews have been completed
- The Town has applied and been awarded a Congressional Grant for \$800,000 (thank you Senator Susan Collins and staff) to be used for this project (Town match of \$300,00)
 - O Though the award of this grant is wonderful it has caused significant delays. The grant is overseen by Housing and Urban Development (HUD) who has several additional requirements that must be satisfied prior to the Town moving forward with the project. The Town has engaged VHB to help navigate these new requirements and reviews. The Town has had several meetings with HUD and VHB to date and continues to make progress. At this time the Town is being informed the review process may take things well into the fall season. If final approval is not received until fall, the project will be delayed until the summer of 2024.

Even though the project is currently moving forward slowly, the Town is thankful for the progress and secured funding. The Town certainly looks forward to completing the project as soon as possible.

b) Milfoil status (Rich)

- Maine DEP concerned about keeping milfoil out of Whitney Pond. They provided us a grant of \$5725 for 2023, lower than amount our association typically receives (\$8797 for 2022, \$8455 for 2021)
- New England Milfoil (NEM) coming last week of July, at cost of about \$8300 for the week. We usually hire them for two weeks but there are not sufficient funds.
- Mats placed down years ago in certain areas of Hogan Pond need to be removed.
 Rich prefers handpicking over mats but willing do either. There are plenty of mats at his house for anyone wishing to place in front of their property.
- Sylvia Wilson heading up plant control monitoring team which patrols Whitney Pond and checks out plants. Water marigold is not milfoil.

c) Watershed status (Bruce)

Katie Goodwin (Project Scientist at Ecological Instincts) gave PowerPoint presentation on completed Phase I watershed project and upcoming Phase II project plans:

- Main concern is phosphorous from soil erosion getting into the ponds
- Water clarity: Hogan (4.1m), Whitney (5.1m), state average (6.8m)
- Phosphorous: 12 ppb (same as state average)
- There were 95 candidate sites identified during initial survey

Phase I (2019/20)

- estimated 134 tons/year of sediment prevented from entering ponds
- estimated 111 lbs/year of phosphorous prevented

Phase II (2023/24)

- \$133,340 project: \$77,910 Maine DEP, 55,430 Non-Fed Match
- Homeowners eligible for up to \$750 matching grant for projects up to \$1500
- Large project on Rabbit Valley Road to redo culvert
- Erosion mulch will be available to homeowners
- Faulty septic systems can cause phosphorous runoff into ponds
- Alewives prevent algae

d) Tax Exempt (501c3) status (Tom)

i. Maine Secretary of State 2023 Annual Report (\$35)

- HWPA was at one time a qualified Tax Exempt (501c3) association but didn't submit annual reports (Form 990) to the IRS. If you don't file a required return or notice for three consecutive years, your exempt status will be automatically revoked.
- HWPA needs to file IRS Form 990 annually to maintain tax exempt status

ii. Apply for IRS Federal approval – 1023EZ (\$275)

• Tom submitted 1023EZ application to IRS at cost of \$275. Our application was approved on 05/30/2023 and HOGAN WHITNEY POND ASSOCIATION is now exempt from federal income tax under Internal Revenue Code (IRC) Section 501(c)(3). Organizations exempt under IRC Section 501(c)(3) are further classified as either public charities or private foundations. IRS determined our association is a public charity.
