The Craft Castle is a free crafting area which is utilized by the general Ephrata community. Latchkey kids and people with special needs are two significant groups serviced at the free craft area. Revenue obtained through sale of donated craft supplies. Paid cashier positions utilized to train special needs youth empowering them with confidence and job skills. Summer job skills youth training program enables both advanced and delayed youth to experience a work environment while developing workplace skills, empathy, and critical thinking. Seven to eleven volunteers each day throughout the year.

Explanation: Migration issues from Quickbooks Desktop to Quickbooks Online caused considerable duplicate and triplicate entries that had to be tracked down and deleted. In the late spring 2023 we filed form 8868 in a timely manner. The decision to close our Hanover location required Joshua Myers, the treasurer/executive director, to be the manpower throughout the summer of 2023 to move all the Hanover resources to the Ephrata location. So, we hired George Sheldon, a bookkeeper through Quickbooks, to help bring the books up to date and when he claimed the books were ready we turned it over to the accounting firm we had previously used, Covenant CPA. Covenant consistently refused to dedicate time to completing our books and filing timely despite being very aware of the short time left to file. We determined toward the end of January 2024 when Covenant had been working on the accounts for almost three months, that they had breached the contract and engaged the services of Bee Bergvall and Co. While reviewing Sheldon Bookkeeping's entries we determined that he had created multiple clearing accounts and would arbitrarily assign entries to various accounts rendering them irreconcilable. Upon cleaning up both Sheldon's and Covenant's confusing and misleading entries Joshua Myers submitted the 990EZ with the most accurate information available. Bee Bergvall and Co was able to do our compilation but encountered some entries which needed corrections and have put us just over the threshold which now require us to file a 990 instead of the 990EZ. Because of these circumstances outside of our control we respectfully request that the late fines and penalties be waived.
