PAYMENT

Payment for the weekly educational services shall be made by the Monday one week prior to the week of service (one week in advance). Payment may be accepted in the form of check, cash, CC/DC, PayPal, or Venmo. If the student is permitted to attend after nonpayment 1 week in advance, a late fee of \$25 per late payment and returned check is required and will be added to the weekly charge. Enrollment will end and the student will be dropped after two weeks of nonpayment. All checks are to be written to Angelique Rogers. The following person is responsible for payment of fees:

SCHEDULED STUDENT START DATE

Weekday education program:

Services charged at the rate of \$ 175.00 dollars per week shall commence on ____/____/____ (month/day/year) and thereafter on a weekly basis as mutually agreed upon by Axiom Academy and Student. The school's hours are 8am to 6pm Monday through Friday except for legal and school holidays and breaks.

CANCELLATION AND REFUND

The student may cancel prepaid weeks in advance for reasons of a family emergency or sickness and receive a refund or apply any pre-payment to future weeks. Weeks not attended for any other reason by the student without giving a one-week prior notice to Axiom Academy shall be charged at the full rate. If Axiom Academy cancels for any reason and at any time prior to the start of the week, Axiom Academy agrees to apply that payment to future weeks that Axiom Academy and Student has agreed upon. No daily refunds are available since enrollment is on a weekly basis.

LATE ARRIVAL AND CHANGE OF SCHEDULE

Fees are calculated according to the schedule agreed upon by Axiom Academy and the Student. No adjustment to fees shall be made for time lost because of late arrival, early termination/departure or absences by the Student. Axiom Academy expects students to be present to at least meet the minimum attendance requirements for the state of Alabama so as not to be considered truant. Cancellation without sufficient prior notice is subject to the terms set forth in the CANCELLATION AND REFUND policy.

OBLIGATIONS OF THE EDUCATORS ASSIGNED BY AXIOM ACADEMY

- The educators undertake to do all preparation prior to structured lessons and to structure lessons in such a way as to optimize time to the benefit of the Students.
- The educators shall keep confidential all information of the Student and shall contact other parties involved in the education of the Student only if given written permission by the Student's responsible party to do so.
- The educators shall at no time be required or obliged or expected to execute homework, assignments, or help with tests on behalf of the Student.

STATUS OF AXIOM ACADEMY

It is expressly understood that the Student retains the services of Axiom Academy as an independent service provider and not as an employee. Axiom Academy shall be responsible for all insurance and statutory declarations and contributions with regard to income tax.

TERMINATION

This contract may be terminated by either party at any time by giving the other party seven-days prior written notice unless special circumstances exist requiring the immediate removal of a student.

RELAXATION OF TERMS

No relaxation, indulgence, waiver or release by any party of any of the rights in terms of this agreement and disclosure agreements on one occasion shall prevent the subsequent enforcement of such rights and shall not be deemed to be a waiver of any subsequent breach of any of the terms.

WHOLE AGREEMENT

This agreement and disclosure agreements constitutes the entire understanding between the parties with regard to the subject matter thereof and the parties waive the right to rely on any alleged expressed or implied provision not contained herein. Any alteration to this agreement must be in writing and signed by both parties.

MINORS

Where the Student is a legal minor, the Parent/Guardian shall enter into this contract on behalf of the Student and shall accept and agree to all the terms and conditions contained herein on behalf of the Student.
