- 3. Reported the corruption in Shashemene to Prime Minister Abiy Ahmed.
- 4.Reported the Unconstitutional arrests of Private, Cultural and traditional uses of Cannabis in South Africa and got over 170 detainees released.
- 5. Updated our transparency report to the Federal non profit database in the U.S.
- 6.Recognized and addressed the Sudan conflict of 2023.
- 7. Started Rastafari community constitution edits in Uganda.
- 8. Updated the formatting on the EWF constitution.

- 9. Issued an amendment to the International Executive council message of 2020.
- 10. Chartered the EWF Local 3 Rehema Foundation Tanzania.
- 11.Became a registered organization and Legal service advisor for refugees through United States Citizenship and Immigration Services.
