**RE: REJECTION OF THE ECOWAS SANCTIONS ON MALI**



There has been a deadly trend and conspiracy on the oppression of Africans as well as Africans in The Global Diaspora. ***We, the Black Peoples of the World, In order to effect Unity, Solidarity, Liberty, Freedom and Self-determination were established to secure Justice and maintain our divine heritage.*** After carefully reviewing the divine history and heritage of Mali we came to the conclusion that no matter what the situation may be, The ECOWAS are using these sanctions to stab the citizens in the back for losing faith in a democracy that does not fit The Ecowas political Agenda. These sanctions are a direct violation of humanity, a violation of the freedom to live, breathe, sustain their health and their immediate financial future. These same sanctions that claim to be necessary for peace, stability and growth lack territorial integrity and will drive them into an unsafe, inhumane fast track to forced poverty and prove that The Ecowas Agenda is designed to destabilize, depopulate, uneducate and inflict more unnecessary pain and suffering. The very organizations that are put in place to promote peace and stability are seeking to enforce a system that has deprived the people of basic necessities needed to survive such as water. **Poor water quality in Mali results in a high risk of waterborne infectious diseases. The large population size of Mali means that 12 million people lack proper sanitation and almost four million do not have access to clean water. 3.5 million people don't have clean water. That's almost 1 in 5 of the population ; 11 million people don't have a decent toilet.**

In America they say you need 8 glasses of water to survive. Your body depends on water to survive. Every cell, tissue, and organ in your body needs water to work properly. The fact that there are puppets in Mali that are not improving the citizens quality of life with their injunctions under the cover of resolutions is completely criminal and absurd. Imposing sanctions on Mali simply cripples the people and plunges them into further unfair living conditions and emotional trauma.

The member states that are imposing the sanctions on the people of Mali may very well be inflicting Human Rights Violations by intimidation tactics, physically excluding the people from banks, assets, financial assistance, economic rights, civil rights, cultural rights etc. These sanctions attack the inheritance of Malians, impose a conviction and unlawful sentence on their beliefs, their ability to enjoy the personal freedoms and space because of their unwillingness to be oppressed and dictated to by colonial slave masters that are disguised as peace makers and putting pressure on other African countries. The track record of these criminals that disguise themselves as peacemakers is a quickly growing serious concern.

The sanctions claim to give aid for Covid so let's take a look at the Covid numbers. **As of 12:01AM ET on June 12, 2022, CDC will no longer require air passengers traveling from a foreign country to the United States to show a negative COVID-19 viral test or documentation of recovery from COVID-19 before they board their flight.** As of June 12, 2022 according to the CDC Covid is a Level 1. Since February there have been less than 100 cases in a population of 20.25 million. We are concerned that the sanctions offering Covid relief may intentionally or unintentionally drive up the infection rates via unlawful vaccines. Mali should not be used as a testing ground for unlawful experiments on human beings. The citizens of Mali should be treated with respect and the resources should be protected with Historical priority. No one of the citizens should be forced to live in inhumane conditions and expected to make democratic decisions under these sort of State of Emergencies. Peacekeepers should enhance the quality of living and assure the people that they have access to ALL inalienable resources. They should be reminded that their resources are not at jeopardy of being stolen, compromised or traded while they suffer to fight for basic necessities and the inheritance of their culture and preservation of the land including their natural resources for the eventual homecoming of the Global Diaspora.

Transition Authorities should respect the peace and promote the historic and economic growth of the land during this time. Notice that nothing has gotten better for the people and for Mali to be so rich in resources there is no humane reason to inflict more pain on the people.
