LOCAL CHARTER REVIEW, SUSPENSION AND REMOVAL

Public Notice Year Starting: August, 2026

In accordance with Federal Guidelines and

Inter-Governmental Organization responsibilities

The Ethiopian World Federation, Incorporated (EWF) will issue this annual notice to explain the standards and general process governing charter review, suspension and removal.

This is a (30) thirty day public notice that lists Local Charters up for removal of all non-profit tax exemptions and immunities.

Standards for Continued Charter Recognition

Each Local must remain in good standing under the controlling EWF Constitution and Bylaws, its charter and any duly adopted International Council directives that fall under applicable law.

Continued recognition includes timely reporting, responsible stewardship of funds and records, authorized use of the EWF name and marks with cooperation of our lawful oversight.

Circumstances That May Lead to Review

Governance or inactivity:

Failure to maintain required officers, meetings, membership, records, or active operations.

Financial or reporting noncompliance:

Delinquent reports, dues or assessments; inadequate records; misuse of funds; or failure to meet tax, filing, or group-exemption requirements.

Misconduct or unauthorized action:

Fraud, malfeasance, serious constitutional or bylaw violations, misrepresentation of authority, misuse of the EWF administrative assistance, EWF name, local charter, marks, or Federal documents.

General Review and Removal Process

The Ethiopian World Federation, Incorporated will follow its Articles of Incorporation EST. 1937, Constitution and Bylaws, New York Non profit laws, International Organizations Immunities Act of 1945, U.S. Treaty of 1951 and any applicable policies. The affected Local will receive our Local Exit Package and (30) thirty days to submit it before final action. If EWF initiates emergency measures our headquarters may enact interim suspension or protective action before final disposition. In that case, New York State Attorney General, Consumer Frauds and Protection Bureau; Federal Trade Commission; FBI Internet Crime Complaint Center; Internal Revenue Service may be sent a preliminary report.

Final action must be approved and recorded in accordance with Federal laws.

Effect of Charter Removal

Upon this effective date, all locals listed in this annual report must return EWF HQ property and complete any required exit documents, accounting, records and banking transfer and reconciliation. Charter removal will cancel any EIN issued by the United States of America, dissolve the Locals in these annual lists and separate as legal entities. This formal removal will not eliminate debts or liabilities, nor will it relieve the former Local or its officers of any federal, state or International fraud investigations. EWF Headquarters will make any required updates concerning its central organization records by **September 1**. The American Republic, The District Attorney of New York and The Secretary of State entries will be finalized by **November 2** and every year thereafter, on **Coronation Day**.

Public Information, Confidentiality and Questions

The Ethiopian World Federation, Incorporated may publicly confirm a charter's current status and effective date. Personnel matters, allegations, evidence, deliberations and protected, traceable tax or personal information will remain confidential except when disclosure is authorized or legally required. **Any questions about this notice or ongoing projects affected by this annual list or requests to verify a Local's charter status should be directed to the International Executive Council at the contact information above.**
