Public Clarification Notice

The Ethiopian World Federation, Incorporated

The Ethiopian World Federation, Incorporated (“EWF”), a New York not-for-profit corporation, acknowledges public circulation of a letter dated December 18, 2025, purportedly issued by the Crown Council of Ethiopia.

Pursuant to N-PCL § 701(a), the governance and management of EWF are vested exclusively in its duly constituted board of directors. Consistent with its fiduciary obligations under N-PCL §§ N-PCL § 715 and N-PCL § 717, which require directors and officers to act in good faith and with ordinary prudence in the best interests of the corporation, EWF formally requested verification and evidentiary confirmation of the document’s authenticity which falsely stated that Scheril Murray was the President of The Ethiopian World Federation with an alleged signature from Prince Ermias Sahle-Selassie Haile-Selassie.

Pursuant to Nonprofit Corporation Laws, EWF commands that the letter being circulated lacks authority, and legal effect as of February 15, 2026.

Pursuant to our Articles of Incorporation filed on August 25, 1937 filed in Supreme Court Article 2 Section F states: To encourage its members to develop interest and pride in American Institutions, to promote American principles and ideals, and to further these objectives of the American Republic.

With respect to the Imperial Highness Prince Ermias Sahle-Selassie Haile-Selassie interviews dated October 19, 2022 and September 11, 2025 we would like to clarify that we do not adopt his ideas of non belief in constitutional law, no unity and no self-determination. Our values are stated clearly in our foundational documents, membership corporation law, democracy and the non-profit laws both federally and state-level regulations regarding incorporation, governance, compliance, fiduciary duties and charitable solicitation.

The thirty (30) day verification period has elapsed without response. In accordance with its statutory duties and corporate governance authority, EWF does not recognize the referenced document as carrying binding corporate, fiduciary, or governance effect within the Federation.

All related records have been preserved in compliance with N-PCL § 621, governing corporate record maintenance and transparency.

Our hope is that Prince Ermias Sahle-Selassie Haile-Selassie will take action on anyone that seeks to defraud the use of his signature and can appreciate our concern in the matter.

This matter is considered administratively closed unless and until competent and verifiable documentation is provided.
