DECLARATION

REJECTION H.R. 7311

Whereas,

The United States Congress is attempting to violate freedom of speech, right, as stated in the [1st](#) and [14th Amendments](#) to the [Constitution of the United States](#), to express information, ideas, and opinions free of government restrictions based on content.

Whereas,

Sec.1.2.a.b. are directly violating the 14th Amendment to the Constitution of the United States, placing government restrictions based on our opinions and decisions to stay out of the American conflict with the Russian government.

Whereas,

Our organization as of 1957 represents over 8,000,000 people of African descent that have the right to an opinion on matters that concern Africa because we represent the marginalized and remain victims under the color of Law (Section 242 of Title 18) in The United States of America.

Whereas,

Section 3.a.1. Of H.R.7311 Is a direct **VIOLATION** of the Economic Treaty between Ethiopia and The United States of America Article VI Section 3. *They shall also be permitted to engage in the practice of professions for which they have qualified.* Article VIII Section I: *Each High Contracting Party shall at all times accord fair and equitable treatment to nationals and companies of the other High Contracting Party, and to their property and enterprises; shall refrain from applying unreasonable or discriminatory measures that would impair their legally acquired rights and interests; and shall assure that their lawful contractual rights are afforded effective means of enforcement, in conformity with the applicable laws.*

Whereas,

In December 2021, We The Black Peoples of the World in America released a **STATE OF EMERGENCY** and have been under a State of Emergency for over 500 years, enduring: brutal physical torture, jim crow laws, molestation, rape, psychological, physiological warfare. Economic oppression, with generational damages passed onto generations. We see this BILL as an attempt to conspire against the African Diaspora
