## **MEMORANDUM**

Subject: Dr. Tedros Adhanom Ghebreyesus Director of The World Health Organization and his active affiliation with Terrorist Organization TPLF



For Human Rights violations
TPLF terrorist Gang Member

**Purpose:** To establish facts that support Dr. Tedros affiliation with the Global Terrorist group TPLF because a state sponsoring such a threat will doubtless go to enormous lengths to ensure that *plausible deniability* is firmly in place. To secure The U.S. Constitution, the U.N. Constitution and protect the freedom of choice to avoid violations of Human Rights.

**Whereas**, On 2006 The World Health Organization Constitution states: **THE STATES** Parties to this Constitution declare, in conformity with the Charter of the United Nations, that the following principles are basic to the happiness, harmonious relations and security of all peoples:

Health is a state of complete physical, mental and social well-being and not merely the absence of disease or infirmity.

The enjoyment of the highest attainable standard of health is one of the fundamental rights of every human being without distinction of race, religion, political belief, economic or social condition

**Whereas,** on June 15, 2014 U.S. Citizenship and Immigration Services put out a memo **PM-602-0101** Stating that The TPLF qualified as a Tier III terrorist organization prior to May 1991. It also stated that The TPLF qualifies as a Tier III terrorist organization under INA section 212(a)(3)(B)(vi)(III) on the basis of its violent activities before it became part of the ruling coalition and the government of Ethiopia in May 1991.

**Whereas,** On May 13, 2017 **The New York Times** released an article stating that Dr. Tedros was accused of covering up three cholera epidemics in his home country, Ethiopia, when he was health minister. *A direct violation of the WHO constitution*.

**Whereas,** In May 23, 2017 Dr.Tedros Adhanom Ghebreyesus was elected **WHO Director-General** for a five-year term by **WHO** Member States at the Seventieth World Health Assembly.

**Whereas,** On November 17, 2017 Ethiopia reported The World Health Organization Director-General Dr. Tedros had been "fully engaged in soliciting diplomatic and military support" for the Tigray People's Liberation Front TPLF.

**Whereas,** On November 19, 2020 on France 24, Army chief Berhanu Jula released an article accusing *Tedros* of *seeking to arm the TPLF* against their conflict with the Ethiopian government. There has been no investigation into his involvement yet he is leading The World making decisions about **The World's Health Organization**. He never responded to these accusations.

**Whereas,** On November 19, 2020 **The Washington Post** reported, while Dr. Tedros is better known as one of the public faces of the International effort to fight the coronavirus pandemic that has ravaged the world, he is also a *high-ranking member* of the Tigray People's Liberation Front. Tedros was Ethiopia's health minister from 2005 to 2012 and then its foreign minister until 2016, when the TPLF dominated the coalition that ruled the country.

**Whereas,** The African Union endorsed Dr.Tedros to get him into office to direct American citizens and individuals on a Global level to trust his opinion on life or death issues, while knowing and seeing photographs of his involvement with the active Global terrorist group TPLF.

**Whereas,** Health security is a central feature of the lead concern of the heads of state and government and it is a clear possibility that the Director of The World Health Organization is a **Third General** of the terrorist group TPLF in Ethiopia.

**Whereas,** There is a great concern and State of Emergency in place for The United States of America and Ethiopia. The U.S. and Ethiopian Peace and Economic Treaty or trade agreement that mostly supports women and children in Ethiopia is at risk during a conflict only making matters worse. It is a possibility that the free trade has been jeopardized and compromised due to the fact that The World Health Organizations Leader was impartial by his involvement as a **Third General** with the Global Terrorist group TPLF.

**Whereas,** We The Black Peoples of the World believe in the policies of The United Nations, we respect the policy of The United Nations and we believe that the meeting about Ethiopia on December 17, 2021 could have accommodated better truth, facts and fairness if there were a translator to speak on behalf of Eritrea, Ethiopia so that, we the people can make a clearer conclusion of the situation.

**Whereas,** if Dr. Tedros is an active and current member of the TPLF Terrorist Group, founded in 1975 then he has carried out attacks on the majority of hospitals and governmental institutions in Ethiopia in the recent conflict therefore destroying the infrastructure and the possibility of peace and wellness. *A direct violation of the WHO constitution*.

**Whereas,** We The People, are requesting a criminal investigation about the involvement of The World Health Organization's Director, Dr. Tedros and a re-evaluation of his ability to make impartial decisions because of his loyalty to the Global Terrorist group TPLF.

**Whereas,** We DO NOT want a terrorist making decisions about our Health or our Childrens Health after hearing him say the vaccine kills children at a press conference.
