CERTIFICATE OF INCORPORATION

THE ETHIOPIAN WORLD FEDERATION, INCORPORATED

(pursuant to the Membership
Corporations Law.)

WE, THE UNDERSIGNED, being persons of full age and being desirous of associating ourselves together for the purposes as hereinafter more particularly described, pursuant to and in conformity with Article II of Chapter 722 of the Laws of 1926, relating to Membership Corporations Law,

We do further certify and declare, as follows:

FIRST: That the corporate name by which said Corporation hereby to be formed shall be known and distinguished is and shall be THE ETHIOPIAN WORLD FEDERATION, INCORPORATED.

SECOND: That the purpose or purposes for which said corporation is formed are as follows, viz.:

A. To promote and stimulate interest among its members in world affairs and to cultivate a spirit of international goodwill and comity.

B. To promote friendly interest among its members, to develop a fraternal spirit among them, and to inculcate in its members the desire to render voluntary aid and assistance to each other at all times.

C. To promote love and goodwill among and for Ethiopians at home and abroad and thereby to work for the maintenance and the integrity and sovereignty of Ethiopia and to disseminate the ancient Ethiopian culture among the members.

D. To render voluntary aid and protection to its members, without fee or charge for the same, when in need, if necessary, and to provide and care for refugees and disabled victims of the Ifalo-Ethiopian War, and in every way to render voluntary aid and assistance as a response to the Ethiopian appeals for its wounded, homeless and blind.

E. To give concrete material and voluntary aid, without fee or charge for the same, to all such refugees and disabled victims and to raise funds by voluntary subscription for the purpose aforementioned.

There shall be no charge, fee beneficiary-tax or other assessment upon the members of this corporation except for dues as may be provided for in the constitution and by-laws of the corporation; and there shall be no cash benefits paid; and the objects and purposes for which this corporation is formed are to be promoted, transacted and carried on without pecuniary profit.

F. To encourage its members to develop interest and pride in American institutions, to promote American principles and ideals, and to further those objectives of the American Republic.

THIRD: That the territory in which the operations of said Corporation are to be principally conducted is the entire world.

FOURTH: That the principal office of said Corporation shall be located in the Borough of Manhattan, County of New York and State of New York.

FIFTH: That the number of Directors of said Corporation shall be three.

SIXTH: That the names and places of residence of the persons to be the Directors of said Corporation until its first annual meeting are:

SEVENTH: That all of the subscribers to the certificate are of full age; that at least two-thirds of them are citizens of the United States; that at least one of them is a resident of the State of New York, and that of the persons named as Directors, at least one is a citizen of the United States and a resident of the State of New York.


