## **MEMORANDUM**

## subject: H.R.S3199 and H.R.6600 written by Mr.Menendez & Mr. Malinowinski and their support of the GLOBAL Terrorist Organization TPLF in the disguise of a "peace agreement"

## To Whom This May Concern:

On November 4th, 2022 Mr.Mendez drafted H.R.S3199 in support of a Global Terrorist Organization TPLF disregarding the Global Terrorism Database putting the World in further danger by supporting the TPLF. On February 4th, 2022 Mr.Malinowinski drafted H.R.6600 in support of a the same Global Terrorist Organization TPLF disregarding the (GTD) Global Terrorism Database plunging the World into deeper violence in disregard of the Human Rights violations that the group has already been documented for. We, The Black People of the World have already been sanctioned, beaten, raped, violated, miseducated and lynched by The United States of America. We have been through a series of public discrimination by the courts, the congress as well as children service organizations that are in place to protect yet have proven to break up our families and fail us for generations.

These sanctions that the congress is trying to pass on our homeland, Ethiopia, are a **direct disregard for our safety and our leaders at home and abroad**. The policies that these bills claim to protect and to serve are reminiscent of the World Police by people in power that have never had our best interest in heart or ever held responsible for the grotesque crimes against humanity that The United States of America continues to commit. The same people writing these false narrative peace agreements seem to forget that in 1951 when The Ethiopian World Federation, Incorporated was established this was the same year that King Haile Selassie I wrote:

Ethiopia Amity And Economic Relations Agreement Treaty of Amity and Economic Relations Between The United States of America and Ethiopia

Our oppressors somehow find the privilege to accuse others of the same crimes they continue to commit against us. By passing these resolutions in the name and disguise of peace, proves to show that in the same sentence the chosen words cause deliberate harm and destruction to the future of our growth. These Bills serve to cripple the status of economic growth on one of our most historical and monumental allies, The Horn of Africa. These "Resolutions" **do not** provide any resolution at all. They are designed to continue the damage, the hurt and pain of the African American people and Ethiopians at home and abroad.

These sanctions directly affect the growth of Americans. They prohibit the growth of our children and our businesses here in America. These "Resolutions" cramp the Historical significance of our forefathers. These "Resolutions" have not been discussed with the American people although the families they affect are not even the same race or cultural background as the people who have written them. This is colonialism in action and **we reject these Bills** as they not only affect the American people but they interfere with ability, stability and attempt to thwart the confidence The World has in **The Nobel Peace Prize winner of 2019 and His Excellency Prime Minister Abiy Ahmed**.

By imposing these sanctions after looking at the GTD (Global Terrorist Database) shows that The United States of America is supporting these Global Terrorists without the participation or approval of The official members of The Ethiopian World Federation, Incorporated. We have posted public notices along with The Ethiopian Government on the status and views of Dr. Terrorist Tedros and his participation in the Global Terrorist group.
