RE: U.N. CONGO PEACEKEEPERS HOLD A RECORD FOR RAPE/SEX ABUSE

To Whom This May Concern: *It has come to our attention that the U.N. sexual abuse crisis epicenter, is Congo DRC.*

Whereas, Congo DRC has a long history of using rape and mutilation as and deliberate military strategy.

Whereas, from 1885 to 1908 - The Leopold of Belgium's atrocities and systematic brutality in Congo has breed deeply indoctrinated crimes against humanity, infestations of European cannibalistic criminal behavior.

Whereas, from 1885 to 1908 - There has been no reconciliation for the forced labour, torture, murder, kidnapping and the amputation of the hands of men, women, and children.

Whereas, The Congolese have an untold history of being kidnapped as children, raised to be The Murderous Leopold of Belgium's soldiers or underpaid Africans.

Whereas, The men of **The Force Publique** who is now known as The Congolese National Army or The ANC, **traditionally severed the lower limbs, the hands, the feet, or even the heads** of the "disobedient" under the orders of their European officers and they would frequently be eaten.

Whereas, Flogging the villagers and burning whole villages was also a prevalent terrorist tactic.

Whereas, There are reportedly around **8 to 15 million murder victims of the congolese genocide and yet still no justice has been initiated.**

Whereas, The people put in power to protect the people of Congo have been subject to continuous conspiracy to commit human rights violations since the 1900's and have a history of repeating these **generational offenses.**

Whereas, There is still very little popular interest in genocides against non-European and non-American including African American people.

Whereas, UN peacekeepers are actively being accused with alarming predatory evidence as pre meditated rapists, human mutilators and manipulators continue to commit heinous crimes Under The Color of Law.

Whereas, UN member states have a responsibility to prosecute their nationals accused of Human Rights Violations; establishing an external oversight organization, completely independent of the United Nations, to act as a “watchdog” over UN operations; establishing an oversight mechanism to monitor the use of American contributions to UN peacekeeping and humanitarian operations; and withholding a percentage of the U.S. contribution to UN peacekeeping operations unless the UN personnel are brought to justice.

Whereas, Investigations have shown that young girls engage in what is commonly called ‘survival sex’ in order to get food, money or protection.

Whereas, The Ethiopian World Federation, Incorporated is a trusted international organization willing to cooperate with the Global Diaspora on treatment and specialized missions to offer solutions for the generational trauma in Congo DRC.

Whereas, The generational trauma has not been addressed or treated by the UN or the Congolese government properly.

Whereas, The greed of natural resources by politicians and foreigners has been the driving force of generational trauma and inexcusable, irreversible corruption.

Whereas, On September 1, 2023 over 40 peaceful protesters were brutally met with immediate open fire in an army crackdown on anti-U.N. demonstrations in the eastern Congolese city of Goma.

Whereas, The brutal situation in Congo, DRC has been going on without any competent international community interference, awareness or successful resolution.

Whereas, All Africans and those seeking peace through true democracy or independence deserve a right to live free of human rights abuses and a right to peace.

Whereas, Secretary-General António Guterres has spoken about “deliberate attacks on UN peacekeepers” but has yet to issue a response or produce a public audit on the well being of (specifically) the victims of the UN peacekeeping mission rapists as well as an account of the victims, the well being of the families affected as well as an update on the children birthed as a result of these U.N. peace officer rapes.

Whereas, Secretary-General António Guterres speaks about deliberate attacks on UN peacekeepers but the international community has yet to get a response or a public audit on the mutilation of mens body parts, trafficked African organs, missing, sodomized children or a timeline forward to heal, house and protect the victims of generational tyranny.

Whereas, reports state that 158 *possibly* innocent people were arrested on September 1, 2023 but no immediate justice has been revealed about the terrorist militia troops that open fired on the peaceful protestors who were demonstrating resilience for *the sake of protecting Human Rights in Congo.*

The Ethiopian World Federation, Incorporated found that in 2012: 1,152 women were raped every day – a rate equal to 48 per hour. That rate is 26 times more than the previous estimate of 16,000 rapes in 2008 reported in one year by the United Nations.

The figures showed 12% of women had been raped at least once and 3% of women across the country were raped between 2006 and 2007.

The situation has increased dramatically since 2012 and no one has been held accountable for any of the Crimes against Humanity that these international peacekeepers claim to uphold and defend. In Fact, it has been reported that some of the foreign troops of the U.N. had been given a raise and are still training other militia on how to commit these punishable war crimes.

The insatiable greed from these officers and The *defacto* leadership has afforded these “peacemakers” a request to leave the continent of Africa, Congo, DRC with immediate effect.

The time is now for New Leadership, New NGO’s and a speedy trial for the troops responsible for these unspeakable crimes. Everyone must swiftly be brought to justice.

The time is now for the U.N. to stop turning a blind eye to the horrific African holocaust that is happening. The time is now to take responsibility for the lack of effectiveness and reform.

All foreign corruption must be removed in order to restore true African peace in Congo, DRC.
