PURPORTED APPOINTMENT LETTER REGARDING MS. SCHERIL MURRAY POWELL, Esq.

Your Imperial Highness,

This correspondence is issued on behalf of The Ethiopian World Federation, Incorporated (EWF), headquartered in New York City, by its U.S. and International legal counsel, pursuant to the Federation's governing constitutional authority and fiduciary obligations.

EWF has received a letter dated December 18, 2025, purportedly issued by your office and addressed to Attorney Scheril Murray Powell as The President of EWF. The letter appears to confer representative authority and makes statements that, if authentic, carry significant organizational, reputational, and legal implications for EWF.

Given the gravity of the document, and in light of recent internal complaints and governance concerns, EWF is formally invoking Article VIII of its Constitution, which mandates strict evidentiary review prior to the initiation, dismissal, or continuation of any disciplinary or adjudicatory proceedings.

Accordingly, EWF hereby demands formal verification of the letter's authenticity, authority, and legal effect.

REQUIRED EVIDENTIARY SUBMISSION

To satisfy constitutional and legal standards, your office must provide verifiable documentary evidence, including but not limited to:

- 1. Written confirmation that the correspondence was authored, approved, and transmitted under the authority of your office
- 2. Proof of authority under which the Crown Council of Ethiopia may appoint or designate representatives affecting EWF governance
- 3. Clarification of the legal status of the appointment (ceremonial, diplomatic, advisory, or binding)

- 4. Supporting documentation relied upon in issuing the letter, including resolutions, authorizations, minutes or official records of qualifying international humanitarian advocacy and U.S. protocols for the members of EWF
- 5. Authentication of signature and letterhead, including chain-of-custody confirmation

DEADLINE & PROCEDURAL NOTICE

Pursuant to Article VIII, EWF hereby provides thirty (30) days from receipt of this letter for submission of the above materials to the EWF Committee on Complaints and Grievances.

Failure to provide sufficient evidence within this timeframe will result in the Committee proceeding under the presumption that:

- The document lacks enforceable authority over EWF governance; and
- No trial or disciplinary action is warranted based on the correspondence.

Should sufficient evidence be produced, the matter shall be transmitted to the EWF Executive Committee within twenty-four (24) hours for deliberation and final determination.

Until verification is complete, EWF expressly reserves all rights, including but not limited to the right to disregard the correspondence for all governance purposes.

This demand is issued without prejudice, and nothing herein shall be construed as an admission, waiver, or recognition of jurisdiction or authority.

We anticipate your timely cooperation.
