3. Narrative

On 11/14/22, at about 2242 hours, dispatch advised they were forwarding a call to my cell phone. My phone briefly started ring, but then it suddenly stopped. For some reason, the call was forwarded to voicemail before I could answer. When the voicemail came through to my phone, I learned it was from J [REDACTED] S [REDACTED]. The voicemail said "Hey, how's it going, um, my name is J [REDACTED] S [REDACTED]. My phone number is [REDACTED]. I just wanted to make a statement to you guys, because I was close friends with Maddy Mogen. I was with her at the Corner Club most of the night and then after we left, we wanted to go to John's Alley and we went to, stopped at Grub Truck. They got Grub Truck, then a car picked them up and they left and went home. I just wanted to make a statement about... (unintelligible) I don't know if anything is helpful, but I was just with them like for a little bit so, if I can be any help, I would like to. Give me a call. Thank you."

Shortly after I got the voicemail, S [REDACTED] called dispatch again, and was successfully transferred to my phone.

At about 2246 hours, I talked to S [REDACTED] on the phone. S [REDACTED] essentially said the same thing he said in the voicemail he left. S [REDACTED] said he was out with "Maddy" at the Corner Club until about 0230 hours. S [REDACTED] said several times he did not know who the "other girl" was that was with them that night. S [REDACTED] described the girls getting into a "silver sedan" after they got food at the Grub Truck. I confirmed S [REDACTED] name, DOB, address and phone number. I also confirmed with S [REDACTED] he drove to his parent's house at [REDACTED] [REDACTED] in Boise. I asked S [REDACTED] how long he planned to be at his

parent's house and he said he was skipping the next week of classes and would remain in Boise until after Thanksgiving break.

S [REDACTED] said he was willing to talk to a detective about his involvement with this case.

S [REDACTED] said he does not have a roommate at his Queen Rd. apartment and that he lives alone.

I recorded our conversation with my dash camera and BWC. The videos were uploaded to the Watchguard server.

I attached the audio file of the voicemail S [REDACTED] left me to this case through Spillman.
