

## VILLAGE OF PERDUE

### BYLAW # 2012-05

#### A BYLAW OF THE VILLAGE OF PERDUE TO AMEND BYLAW 2010-4 and 2010-10, KNOWN AS THE BYLAW TO CONTROL ANIMALS IN THE VILLAGE OF PERDUE

The Council of the Village of Perdue in the Province of Saskatchewan hereby amends the Bylaw to Control Animals in the Village of Perdue as follows:

**1. Remove Section 3(a) and replace with the following:**

Every owner of a dog or cat within the Village shall cause each such animal to be registered with the Village office.

- i) At the time of registering, the applicant shall complete an Application for Registration of a Dog or Cat as set in Appendix "E", and provide the Village office with a physical description of the animal, the breed of the animal, and the name, address and telephone number of the owner/possessor of the animal, and
- ii) A rabies certificate valid for the registration year is to accompany the Application for Registration. Where the cat or dog is under the care of a registered Veterinarian and provides documentation citing the dog or cat is not suitable for a rabies vaccination, the owner of said dog or cat is not required to vaccinate said dog or cat.

**2. Remove Schedule 'B' and replace with the following:**

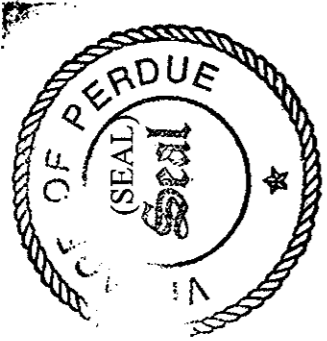



- a. This bylaw shall come into force and take effect on the date of the final reading thereof.


