BYLAW NO. 2012-9

A BYLAW OF THE VILLAGE OF PERDUE TO FIX THE UTILITY RATES


This Bylaw may be cited as the Village of Perdue Utility Rates Bylaw.

The Council of the Village of Perdue in the Province of Saskatchewan, enacts as follows:


1. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule 'A' attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Persons or entities who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
3. All utility users shall pay a quarterly infrastructure fee as stipulated in Schedule 'C'.
4. Accounts for water service and/or sewer service shall cover a period of three successive months. Accounts shall be paid within a period of thirty (30) days from the billing date. Accounts showing arrears sixty (60) days following each billing date will be disconnected. If the water supply to a dwelling unit is disconnected for infringement of the provisions of the bylaw, the same shall not be reconnected until all penalties, fees, rates, charges and arrears as stipulated in this bylaw.
5. A penalty as stipulated in Schedule 'C' will be added to all water and sewer accounts outstanding after 30 days.
6. Unpaid utility accounts for service provided to a property may be added to and form part of the taxes on the property for which the utility service was provided, in accordance with *The Municipalities Act*.
7. Bylaw No. 2011-04 is repealed.
8. The rates, charges, tolls or rents contained in this bylaw shall come into force and be effective for the billing period after the day of approval being issued by the Local Government Committee.





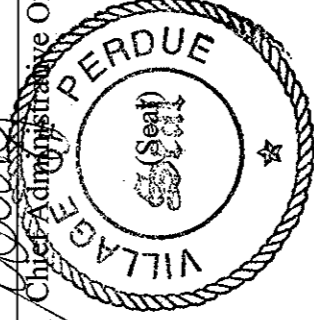
