

## TIREWISE COVERAGE SUMMARY

**Eligible Tires:** Vehicle's tires that have a minimum remaining tread depth of 2/32 of an inch, and tires that are free of any manufacturing defects.

### CONTRACT PROVISIONS INCLUDE:

- Choice of 12, 24, 36, 48 or 60 months term.
- New and pre-owned passenger vehicles/trucks and vans with original equipment manufacturer (OEM) approved specifications.
- Limits of Liability: Determined by NADA trade-in value.
- Prior authorization and a claim number required before work is commenced, except for Emergency Claim Procedures.
- Agreement can be transferred to a new owner within 30 days from date of sale. There is a \$50 transfer fee.
- If canceled within 30 days of purchase, refund will be 100% of amount paid, less any claims paid. If canceled after 30 days, the refund is calculated on a pro-rata basis, less \$50 cancellation fee and less any claims paid.
- Coverages:
  - Tire Replacement: If covered tire cannot be safely repaired, the tire will be replaced with tires of like kind and quality.
  - Wheel (Rim) Repair/Replacement: If damage prevents tire from forming an air tight seal or cannot be balanced, the wheel will be repaired or replaced with like kind and quality (curb damage is not covered).
  - Flat Tire Repair: If covered tire can be safely repaired, coverage amount is \$35 (maximum)/\$65 (maximum for run flat) per occurrence.
  - Roadside Assistance: In the event of road hazard damage, \$100 (maximum) per occurrence for towing or flat tire changing assistance.
  - Mounting and Balancing: In the event of road hazard damage, tire/wheel mounting and balancing coverage is \$30 (maximum)/\$40 (maximum for run flat).
  - Rental Car Reimbursement: In the event of road hazard damage which results in the covered vehicle becoming inoperable, coverage includes car rental reimbursement of \$35 per day (maximum), up to three days.
  - Trip Interruption: In the event of road hazard damage more than 100 miles from home, coverage includes a maximum of \$100 per day, up to three days and \$300 (maximum) per occurrence.
  - Alloy Wheel Cosmetic Damage Repair (optional coverage): Repairs minor cosmetic damage to the alloy wheel with a maximum repair amount of \$150 per occurrence and up to \$800 (maximum) over the agreement term.
- Vehicle Exclusions:
  - Vehicles used for competitive driving or racing, police or emergency service, principally off-road use, snow removal, carriage of passengers for hire, commercial towing, construction, postal service, farm, ranch or agriculture, motorcycles, or trailer.
  - Alfa Romeo, Aston Martin, Bentley, Bugatti, Ferrari, Fisker, Harley-Davidson, Kawasaki, Lamborghini, Lotus (except Elise and Exige), Maserati (except Ghibli), Maybach, McLaren, Peugeot, Rolls-Royce, Spyker, Sterling, Tesla, Triumph, Victory, Yamaha and Yugo.
