To Originator Agreement

THIS PRODUCT LINE ADDENDUM (“Addendum”) is made a part of the Originator Agreement between Wise F&I LLC (“Provider”) and _____ (“Originator”) (hereinafter the “Originator Agreement”), and is entered into by and between Provider and Originator.

Originator expressly agrees that this Addendum may be unilaterally amended and/or replaced by Provider at its sole discretion, and such amended or replacement addendum shall be effective thirty (30) days from the date issued unless otherwise indicated.

- **Vehicle Eligibility:** If a Vehicle is not identified as New or Pre-driven, the Pre-driven coverage will apply. Model year is determined as of January 1st of the calendar year. Eligible Vehicles must be free of any Pre-Existing Conditions known to You. Vehicles utilized for Commercial Use are not eligible for coverage. Vehicle eligibility subject to the limitations and exclusions found in Section IV of Contract(s).
- **New Vehicle means:** Current model year plus one (1) year old with no mileage restriction. New Vehicles qualify for up to five (5) years of coverage benefits or a maximum Agreement Term of sixty (60) months.
- **Pre-driven Vehicle means:** Current model year plus up to seven (7) years old and does not otherwise qualify as a New Vehicle with no mileage restriction. Pre-driven Vehicles qualify for up to three (3) years of coverage benefits or a maximum Agreement Term of thirty six (36) months. Vehicles older than eight (8) model years do not qualify for coverage under this Agreement.
- **Contract’s length of agreement options include 12, 24, 36, 39, 48 and 60 month terms and are subject to the Vehicle Eligibility guidelines described above.**
- **Bundled coverage plan: WiseCARE Complete Plan includes all of the following coverage benefits: PDR, CAWR, WSD, Int/Ext and ERA. Availability of individual coverage benefit(s) subject to state-specific guidelines. See Contract(s) for details.**
