If you're an independent older adult, we know you're happiest at home. You want to enjoy the comforts of family and community for as long as possible. If a chronic medical issue makes it difficult for you or a loved one to live at home, Pacific Northwest PACE Partners has a care solution for a healthier, happier senior life—and peace of mind for family caregivers.

The Pacific Northwest PACE Partners Program of All-Inclusive Care for the Elderly (PACE) is a Medicare and Medicaid program that provides all the care and support services you need. We monitor your health, medications and well-being to keep you healthy and safe at home, and prevent the hospitalizations, illnesses and nursing home placements seniors often face.

### IS PACE FOR YOU?

You are eligible for Pacific Northwest PACE Partners if you:

- Are 55 years of age or older
- Are able to live safely in a community setting
- Meet Washington state Medicaid requirements for nursing home level of care
- Live in the PNW PACE Partners service area (see the back of this brochure for service areas)

## COMPREHENSIVE, CUSTOMIZED CARE

Once you're enrolled, our team of health care professionals will work with you or your family (when appropriate) to assess your specific needs, develop an evolving care plan and deliver coordinated services through our Pacific Northwest PACE Partners center in Tacoma. Your individualized plan covers all medically necessary services, including:

Primary and specialty medical and nursing care	Prescriptions and over-the-counter medications
Lab tests and diagnostics	Medical supplies and equipment
Dental, hearing, vision and foot care	Mental health services
Therapy and social work services	Rehabilitation
In-home care and services, (light housekeeping, bathing/showering assistance)	Adult day health services, meals and social activities
Emergency services	Transportation
Other services determined to be necessary for you through the PACE program	

In addition to on-site care provided by your team, Pacific Northwest PACE Partners provides specialist or secondary care as needed, as well as other custom services beneficial to your health and well-being.



## NO COST FOR ELIGIBLE SENIORS

Seniors who meet the program eligibility requirements and are eligible for Medicare and Medicaid receive services at no cost. There are no deductibles or co-payments for any drug, service or care approved by your Pacific Northwest PACE Partners care team.

If you meet the program eligibility requirements and have Medicare but do not meet financial eligibility requirements for Medicaid, you may be responsible for the portion of your bill.

If you meet the program eligibility requirements but are not eligible for Medicare or Medicaid, we're happy to discuss a private pay rate with you.

If you opt for out-of-network medical services without prior authorization (with the exception of emergency services), you may be liable for the full cost of those services.
