Dickey for life, remainder to his children per stirpes (revoked by codicil to provide that the children's share be distributed as follows: principal of the $\frac{1}{4}$ to Matthew W. Dickey, at his death unto all or such on or more exclusively of the others or other of his six children, in such amounts and in such manner as the trustees shall, in their unlimited discretion, deem proper and the making of such payments and the statement thereof by the trustees shall be conclusive of their correctness."
