



### AFFIDAVIT IN SUPPORT OF PLAINTIFF'S MOTION FOR SPECIAL ORDER

Lisa C. McManus, being duly sworn according to law, deposes and says the following:

- 1. I am the plaintiff's attorney in the above action.
- 2. I personally investigated the whereabouts of defendants in this action.
- 3. In order to appropriately identify the heirs of all defendants, I reviewed the original Elk County abstract of title regarding the subject property and all of the deeds in the abstract to attempt to locate last known addresses or counties of residence for each individual that might have an interest in the subject property.
- 4. I requested abstractors to research the county records in the Commonwealth of Pennsylvania for each individual who appeared to have lived in a county other than Elk County.
- The search of Jefferson County records revealed the existence of a quitclaim deed that led to the identification of the current whereabouts of the defendants in Defendant Group Four.
- 6. Linterviewed Thomas G. Reitz, Michael Kubico, James Lauer, and Linda Lauer to obtain information as to the whereabouts of the Reitz or Kelso defendants, their heirs or assigns.
- 7. Thomas Reitz was able to provide information as to the last known location of a number of heirs as of forty years ago, through which I focused search efforts on those locations.
- 8. I researched the names of all heirs that were identified through the discussions with the heirs that were located and through a search of the records at the Elk, Jefferson, Warren, or McKean County courthouses on PeopleFinders.com, Bing, and Google.
- With regard to any addresses that I located that could potentially lead me to the current whereabouts of defendants in groups One through Three, I sent letters to those individuals at the available addresses by United States Postal Service, certified

- mail, return receipt requested. The letters were returned with notations that they could not be forwarded or no such address existed.
- 10. I researched defendants in groups One through Three in the social security death records; however, no relevant records were found.
- 11. I reviewed deeds involving the named Defendants for a grantee address, but found none that were current.
- 12. A search of the Jefferson County courthouse records revealed that an action was filed against Defendant Group One at Civil Docket No. 456-1998 on June 8, 1998, in which Plaintiffs filed an Affidavit Re: Whereabouts of Defendants indicating that good faith efforts had been made to locate the whereabouts of the defendants but were unsuccessful. Information from this complaint was used to further research Defendant Group One.
- 13. A search of the Elk County courthouse records revealed that a quiet title action was filed against William Kelso, William Kelso and S.M. Moore at Civil Docket No. 80-364, in which plaintiffs alleged that those defendants were dead and that the identity and whereabouts of their heirs and assigns was unknown. Judge Greiner entered a default judgment against those defendants.
- 14. I did not review the local telephone directory because to do so would have been fruitless because either 1) the heirs identified have been long dead, based on the dates in the documents to which they were parties, or 2) the heirs' last known addresses were not local.
- 15. I have been unable to locate any information on Defendant Groups One through Three that has led to finding their present whereabouts.
- 16. I requested Deborah Carapella, an independent contractor providing services to Penn-York Abstract Corp., to research the records at the Warren County public offices, including the Recorder of Deeds' Office, Prothonotary's Office, and Tax and Assessment Records Office for information relative to Bertha Elliott and John W. Elliott, who were defendants in Defendant Group Two in the original complaint. Based on the information that she provided, I was able to locate and obtain quitclaim deeds from all Bertha Elliott and John W. Elliott heirs except for Richard Elliott, Jr., who cannot be located but is believed to be deceased based on my conversations with his distant cousins.

- 17. No efforts to serve Defendant Groups One through Three have been made as no address can be located.
- 18. The allegations in the foregoing Motion for Special Order and the attached Exhibits are true and correct to the best of my personal knowledge, information and belief.
