Prevention & Recovery Supervisor

1 – Permanent Full-Time

The suitable candidate will be able to perform the following duties:

- Carries out the Mental Health and wellness program in accordance with the WWC program objectives, procedures, policies and community needs.
- Participates in community development projects, strengthening family functioning, and assisting in crisis intervention plans and services for communities.
- Provides suicide risk assessments, monitoring care plans, counselling and case management services with respect to Mental Health & wellness issues.
- Provides Grief Recovery and Critical Incident Stress Debriefing counselling and interventions for youth, adult and groups.
- Supervises Prevention & Recovery team members on day to day basis and assisting them as required.
- Participates in program review and submitting budget needs pertaining to staff, facilities, supplies, and equipment.
- Assists P&R Manager in preparation of funding proposals, collection of relevant statistical date to use for program planning such as monthly, quarterly and annual reports.
- Facilitates education support and therapeutic groups on a regular basis.
- Participates in continuing educational sessions, planning of community experience for students, and utilizes a team approach in problem-solving and decision making.
