Waiver for North Georgia Homeschool Athletics Football Season From April 1 through December 31, 2024

For All Athletic Activities Associated with Football Season

ATHLETIC RELEASE, WAIVER OF LIABILITY, AND COVENANT NOT TO SUE
(hereinafter referred to as the "Agreement")

For the sole consideration, the sufficiency of which is hereby acknowledged, of the right for my child to participate in the athletic/sports program known as **North Georgia Homeschool Athletics Football Program (hereinafter referred to as "NGHAFP")**, the undersigned does hereby agree to the following relating to the NGHAFP. I fully and voluntarily consent to my child's participation in the NGHAFP. I hereby acknowledge my awareness that participation in the NGHAFP could include certain physical activities that may expose me/my child to risk of social and economic losses, property damage, bodily or personal injury, resulting not only from the participant's own actions, inactions, or negligence but the action, inaction, and negligence of others, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.

To the best of my knowledge, the below named Participant does not have any physical limitations, medical ailments/ limitations, physical or mental disabilities that would limit or prevent him/her from participating in the NGHAFP. Further, I hereby state that the NGHAFP OR ITS COACHES is not responsible for any pre-existing injury or reoccurrence of any undisclosed pre-existing injury or illness of the camper/participant prior to the first day he/she registers. I agree to instruct the minor participant that prior to participating he or she should inspect the facilities and equipment to be used, and if the participant believes anything is unsafe, he or she should immediately advise his or her coach or supervisor of such condition(s) and refuse to participate.

In exchange for my child being allowed to participate in the NGHAFP, I hereby release and forever discharge and agree to indemnify all coaches, including but not limited to Coach Austin Harmon, Coach Luke Harmon, Coach Dustin Gillespie, Coach Blake Dotson, Coach Shaun Atkinson, Coach Dusty Mathis, Coach Jeff Birmingham, Coach Kirk Dotson, Coach Marc Sikorski, and all of the agents, staff, presenters, volunteers and facility providers associated with North Georgia Homeschool Athletic Program (**all of which are hereinafter referred to as "Releases"**) from any and all claims, demands, rights, expenses, actions and causes of action of whatever kind of nature, arising from and by reason of any and all known and unknown, foreseen and unforeseen bodily and personal injury, damage to property, and the consequence thereof, resulting from participation in or in any way connected with the North Georgia Homeschool Athletics Football Program. I further covenant and agree that for the consideration stated above, I will hold forever harmless and will not

take legal action against the Releases for any claim for damages arising or growing out of my child's participation in this activity whether caused by negligence or otherwise.

Should the Releases or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold the Releases, and anyone acting on their behalf, harmless for such fees and costs.

I certify that I understand and have read the above carefully before signing. I acknowledge and represent that I freely and voluntarily sign this Athletic Release, Waiver of Liability, and Covenant Not to Sue, and that it is my express intent that this Agreement shall contractually bind my heirs, executors, administrators, and assigns, and my child's heirs, executors, administrators, and assigns, as well as myself and my child.
