### What Principal Illness Navigation (PIN) helps with



- 📅 Coordinating appointments, referrals, and follow-ups
- 📝 Visit readiness: questions, notes, and next steps
- 📌 Tracking tasks so nothing is missed
- 💻 Care transitions (hospital → home/rehab)
- 🤝 Caregiver support and check-ins

#### CMS ELIGIBILITY AND COVERAGE CRITERIA

**Definition:** A serious, high-risk condition that poses a significant risk of hospitalization, nursing home placement, acute exacerbation/decompensation, functional decline, or death.

**Duration:** The condition must be expected to last at least **three months**.

### Examples of conditions that may qualify (pending physician/QHP approval)

Examples are not exhaustive. Many serious, high-risk illnesses may qualify if they meet CMS criteria.

#### ONCOLOGY

- 🟡 Cancer (any type) — active treatment, complex care plans
- Blood cancers (e.g., lymphoma, leukemia)
- Complex post-treatment survivorship planning

#### PULMONARY

- COPD
- Chronic respiratory failure / oxygen dependence
- Pulmonary fibrosis / interstitial lung disease

#### CARDIAC / VASCULAR

- CHF (heart failure)
- Coronary artery disease / post-heart attack recovery
- High-risk arrhythmias (per physician/QHP)

#### NEUROLOGIC

- Alzheimer's disease & related dementias
- Parkinson's disease
- MS, ALS, post-stroke complexity

#### INFECTIOUS / IMMUNE

- HIV/AIDS
- Complex autoimmune disease with high-risk complications
- Transplant recipients with complex care coordination

#### RENAL / METABOLIC

- Chronic kidney disease (advanced/high-risk)
- Dialysis-related care coordination
- Diabetes with serious complications (per physician/QHP)
