



- 4 The previous period/year figures have been regrouped/ reclassified and recasted wherever necessary to make them comparable.



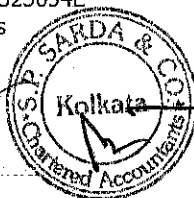


