Referendum Vote for Brodhead School District on April 2

We are excited about the opportunity to present our facility (bond) referendum on April 2.

The referendum question on the ballot states the following:

Shall the School District of Brodhead, Green and Rock Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$17,485,000 for the public purpose of paying the cost of a school building and facility improvement project consisting of: construction of additions, renovations, including for secure entrances, window replacements, bathroom upgrades, capital maintenance, building infrastructure and site improvements at Albrecht Elementary School and Brodhead Middle School; construction of an addition and renovations at Brodhead High School, including for a secure entrance and office; and acquisition of furnishings, fixtures and equipment?

We have sent out a great deal of information over the last three months to help everyone understand the scope of our referendum, the process we used to involve stakeholders in our recommendation to the School Board, the estimated average tax impact on a Brodhead School District property owner, and how these changes could benefit our District for years to come. We are hoping all the information we have provided will help our District residents make a well-informed decision when voting for the future of our schools in Brodhead. We definitely want to see a large turnout for this referendum so we know we have a great representation of what our taxpayers want.

Citizen Concerned **About Water Quality in His** Neighborhood By Grace Kufahl

A citizen that lives on 12th Street brought in a jar of yellowish water that he said came from his tap. He said the city has been over to check it out, but after running the water for five minutes, it comes out clear and tests okay. He stated there are three other households he knows of in his area that also have concerns about their water quality. Mayor Jones told him that the Council would not be able to address his concern at the meeting, but that he would bring it up at a meeting with department heads later in the week.

Alder Gritzmaker questioned Attorney Schroeder regarding who may add to the Council Meeting agenda. He had wanted to discuss the Pearl Island Certified Survey Map and Green County Landfill Contract in open session and it was put on the agenda in closed session. Attorney Schroeder stated council members may add to the council meeting agenda and he advised alders to be clear about what they're requesting. Alder Simpson stated he had a list of things that were not added to the agenda that he felt should have been added regardless of how small or trivial they were deemed to be.

Regarding the complaint the emergency siren can't be heard in the 23rd Street area, Alder Simpson had brought up the possibility of moving it to Chief Raupp. Raupp stated he would like to test the siren.

Referendum point of view from Community Licensed Childcare Businesses

The upcoming referendum is not only building and maintenance improvements, it also states that the half-day 4K program will be expanded into full day 4K. We understand that old buildings need updating and there are safety features that should be addressed. We do not disagree with this maintenance but the 4K going full days will have consequences for the entire community and we wanted everyone to be aware of this.

As childcare providers we are part of the community. We work long hours and for very low wages with no benefits. We share the love of children and enjoy what we do. We have college degrees and are certified to teach preschoolers. That is our job and you as a community will have a say on Tuesday, April 2nd as to whether we will continue to support the children of this community or be forced to make some hard decisions.

Chelsea Andrews, Owner of The Nurturing Tree Academy and Little Learners Daycare in Brodhead, also voiced similar concerns and how an approved referendum will be devastating for the children and the pocketbooks of the families in her care.

Jodi Schwartz from Tiny Town Daycare and Preschool stated that parents need to remember that all day 4K sounds convenient, but they will still need before and after school care for these children and in all honestly we are not accepting any more school agers because I can't afford to fill a fulltime spot with a part time school ager spot. Plus, I firmly believe that we should

My greatest attribute is that I am a positive person who looks for solutions to challenges rather than just pointing out the challenges. I have a strong math background and know what it takes to balance a budget. I am also skilled in the art of negotiation which is also a strength needed to be Mayor.

I am an active member of the Lions Club, Brodhead Optimists and the American Legion. We attend the Living Word Church. I enjoy going to many of the festivals and activities that Brodhead hosts.





Mental health bill passed By Bridget Mouchon,

NAMI Green County President

In a mental health crisis, immediate expert care can transform the worst day of your life into a turning point. A newly passed bill from Senator Howard Marklein and Representative Clint Moses establishes regional crisis urgent care centers—psychiatric emergency rooms-to serve people who walk in or are brought by first responders. Today, people must sit...and wait for hours in emergency rooms for medical clearance before being released or transferred to psychiatric hospital. It's frustrating and traumatizing, wasting precious time that could be spent helping the person find a different path.

The new crisis centers will be staffed 24/7 with prescribers, nurses, and counselors to assess mental health, substance use and medical conditions. They will provide mental health and substance use care on site for a few hours or up to five days. With immediate mental health crisis care, fewer people will need to go to psychiatric hospital. And if the person does need to be transferred to another facility, the bill stipulates that transportation will not be provided by law enforcement. Join NAMI Green County in thanking Senator Marklein and our legislature for passing this important bill and ask Governor Evers to sign it into law.

be allowed to offer the 4K program within our center and want parents to be aware that this is also something we are trying to fight for in our legislation. These kids are already being pushed to sit and learn from an earlier age than I was, and I think it's why we see so many more behavior/attention issues these days. Let the kids play...this is how they learn at this age, not sitting and doing worksheets.

The referendum that is being proposed would remove the fouryear-olds from our care for a large part of the day. If you are like most parents, you work beyond the 3 p.m. school day. Your children will need to find care after school. Children form attachments with their caregivers and can be confused by the disruption of going from home to daycare to the bus to school and back to the bus and then back to daycare before going home. These kids will have long bus rides and are exposed to kids up through high school. I live on the edge of Brodhead a couple of miles from the school. Kids in this area are picked up at 7 a.m. and the 4K children arrive here 55 minutes after they get out of school. This means these little ones spend almost two-hours of their day on a bus. With more students being added to the bus routes this will add longer times to each route. This takes an emotional and a physical toll on children at this age.

If the school implements all day 4K, daycares will have to depend on the youngest children to fill enrollments. As the children get younger, they require more attention and thus we are only allowed a few of them each day. Currently under state licensed home daycare rules we can take eight children but if we have to care for primarily ages 0-two then we can only have four children, forcing us to substantially increase prices and only helping half as many families. Before and after school care will probably not be offered in home daycares. Daycares may close as opposed to imposing large rate increases on young families. Our income needs to support salary, food, crafts, furniture, toys, educational supplies to nurture and support your children's emotional, physical and social needs. We are the first educators these children will see, and we take that very seriously. If we can't provide quality care, then we could be forced to

When I was working outside the home, I was using childcare outside of Brodhead as the few licensed childcares that were here were always full and had a five-year waiting period. I was considering open enrollment of my children to the next community because that was where the available childcare was. I fear that passage of the referendum in its present form could create consequences that result in licensed childcare loss in this community.


Why are we taking a school that states it has no space, not enough money to pay staff and expenses and adding more children? More children to the lunchroom, two more classrooms, two more teachers. Per DPI changing 4K to full day will not increase state funding at all. When Brodhead went to full day 5K the implementation of 4K began. Can we expect 3K to be far behind? Is that the route we want to go as a community?

Let the children be little and grow before they are placed in public schools. Let them develop physically, socially and emotionally so they can be successful. Stress is a major concern and the more transitions a child has the less secure they feel. Let's grow happy secure children in Brodhead.
