

School Board Information Presented on SAFE Club at High School and Middle School

Jessica Gardipee, School Counselor, presented information on the SAFE Club at the Middle and High Schools. SAFE stands for Students Advocating for Equity and is a GSA or Gender Sexuality Alliance. The group was established to acknowledge and show respect and consideration for members of the LGBT+ community. The Board approved SAFE to be recognized as a school sponsored club.

Lisa Semrow, Middle School Principal, informed the board that, in honor of Youth Art Month, student art is on display at the Public Library through March 31st. Also, of the students with artwork displayed at the Common Wealth Gallery, pieces from Elise Rear, Matthew Nordeng and Brielle Engen were selected to go on to the State Art Show.

Dave Novy, District Superintendent, and each of the building administrators discussed their progress toward mid-year goals. Mr. Novy advised they've revamped the

process of observing and evaluating teachers. He explained they're sending home paper report cards to improve communication, they've adopted a new code of conduct for consistency among schools and are offering additional support to new staff.

Kelly Knox, Elementary Principal, told of great progress on the first grade Phonics Screener, 4k Outreach, Kid Connection events, staff acknowledgments and Wellness Wednesdays.

Lisa Semrow reported on their Target-Based learning system including changing report cards to a 3, 2, 1 rating scale. This means the end of the honor roll. She also talked about collecting and responding to feedback in monthly surveys and the Teen Connection parent group.

Jim Mathys, High School Principal, advised new Cert Assessments provided better data on student progress, Reading and Math interventions for grades 9 and 10, posi-

Mayor Addresses Joint Finance Committee

On Tuesday, April 12, I, your Mayor Casey Jones, testified in front of the State Joint Finance Committee at Wisconsin Dells. I signed up at 8:30 a.m. for my turn to speak to the committee. I thought I was early. However, it seems a lot of people had causes worth speaking about concerning the upcoming state budget. Testifying began at 10 a.m. Each testifier was allowed two minutes to address the committee. I was finally able to speak to the committee at 4 p.m.

After I listened for about two hours, the Mayor from Appleton was called to speak. He did a very good job of describing the mechanics of the legislation to the committee in his two minutes. I listened intently to the message he was conveying. After he finished, I tracked him down in the lobby to congratulate him. While in the lobby I met the author of the legislation needed to help prevent my hometown of Brodhead from suffering the loss of several of our social programs because of the lack of funding available due to the defeat of the refer-

endum. I refuse to give up hope on being able to get funding from other sources.

The author had several Mayors with him listening intently to the message that we needed to convey to the committee. The Mayors, who were all from larger cities, seemed to want to spend their time giving the committee their take on why the bill would work. They all had suits and ties and spoke very nicely.

The Mayor from Appleton recognized me from a few other conferences we had attended together. He invited me over to have our picture taken together. As you can see from the picture, I was dressed in my best pair of bibs. After all, I was representing not only Brodhead but all cities classified as rural. I shared with the author of the bill and the Mayor the message I was going to convey. They liked the message I was going to convey which was a lot different than theirs. They showed their support by hanging around until I was able to speak to the committee.

Finally, my turn had come. As you can imagine, the members of the committee seemed kind of worn



out after six hours of listening to testimonies. I, quickly, introduced myself as Casey Jones, Mayor of my hometown, the rural city of Brodhead. I let them know that I was wearing my bibs because the last suit I wore didn't fit. That instantly brought their attention to the message I was about to present. I let them know that I was in favor of the proposed funding because it had a built-in inflation hedge because the funding was based on a portion of the sales tax. I saw several head nods and lots of notes being taken.

That is where I left the mechanics of the shared revenue funding

The onset of spring brings beautiful wildflowers to the woodlands of Illinois, which is home to a rich variety of common and rare spring ephemeral wildflowers. They are called ephemeral because the flowers typically only occur for a couple of weeks in the spring before disappearing for the rest of the year. These plants deploy an amazing array of strategies to deal with the challenges of living on the forest floor. This talk will cure your winter blues by discussing the myriad of adaptations of these interesting plants. Chris Benda is a botanist and past president of the Illinois Native Plant Society (2015-2016). Currently, he works as a Researcher at Southern Illinois University, where he coordinates the Plants of Concern Southern Illinois Program and teaches The Flora of Southern Illinois. Besides working at SIU, he conducts botanical fieldwork around the world, teaches a variety of classes at The Morton Arboretum, and leads nature tours for Camp Ondessonk. He has research appointments with the University of Illinois and Argonne National Laboratory and is an accomplished photographer and author of several publications about natural areas in Illinois. Dale was born April 5, 1923, in Monroe and raised in Twin Grove. He is survived by his daughter, Lureen Honig of El Paso, Texas; his granddaughters and their families, Renée Viens (Michael and sons: Nicholas and Andrew) of Tewksbury, Massachusetts, Heather Honig of The Colony, Texas, Stephanie Stager (Ted and daughter Emma) of Macomb, Michigan; great granddaughter, Megan Parr (Taylor and son Hudson) of Plano, Texas; and his son-in-law, Dr. William Zeiger of Macomb, Michigan. tive contacts home and his weekly newsletter to teachers.

and focused on what it was going to cost our hometown. I explained that after years of budget cutting and tough choices being made, we hit the tipping point. Our budget for 2023 was dramatically increased by over \$350,000. The increase was because of our need to fund Fire and EMS services on a full-time basis instead of our reliance of volunteers. This is a problem that is absolutely not just specific to Brodhead. All small towns are suffering the same challenge. The Council made the choice to use the city’s Fund Balance (savings) to fund the budget shortfall for 2023 while we went to the voters to allow them the choice of whether they wanted to fund the programs that were not mandatory for us to fund.

Our voters elected to not fund the shortfall. Our referendum failed. Programs such as Parks and Rec, Library, Senior Center, the swimming pool, BID Board and other programs and services are on the chopping block. I let them know that small towns and cities are in trouble because the current Revenue Sharing is broken and not being the program that is was introduced to us many years ago as evidenced by the Eight Billion Dollar surplus sitting in Madison. I made it very clear to the committee that small-town life in Wisconsin is in grave danger.

Two minutes flies by even for an experienced auctioneer like me. I wondered if I had made our case clear. The crowd was told all day to refrain from applause because it would slow the hearing down. I was surprised and very happy to see the whole back corner of the room stand up and shake their hands above their head (sign language for applause) as I left the room. More than a few of them came in the hall, shook my hand and wished me a safe trip back to Brodhead. It is my sincere hope that my two minutes will stick in the committees’ heads when they take their thoughts and recommendations to the full legislature.

I urge you as citizens of Brodhead to send emails to our legislatures in support of fixing the Revenue Sharing process.

I will not give up the character, lifestyle and just plain goodness of my hometown without a fight. I will continue to find ways to preserve them without piling more burden on our property taxes and the taxpayers.
