City Council Information shared on possible changes to Sugar River Recreational Trail

Dusty Kubby attended the City Council meeting to share information on possible changes to the Sugar River Recreational Trail. The DNR can petition the federal government about changes to a trail every fifteen years. Because of the poor upkeep of the trail and the increased interest in ATVs, the DNR asked for opinions from the municipalities along the trail.

They are considering a mixed-use trail that would be large enough to accommodate hikers, bikers and ATVs. Local ATV clubs would then be involved in maintenance. It was emphasized that the process, if started, will involve many more steps. At this point, the municipalities are simply stating that they are interested in further investigation. This passed on a 4-3 vote.

The John Pierce Certified Survey Map for Block 192 was approved with some stipulations. The properties are okay with the variances included, but a firewall will be needed if the garage is changed or if the property is sold. The house property will be rezoned R2.

The Council voted to resend the Resolution 2020-005 declaring the Public Health Emergency since the state has done the same.

The Council approved the City Hall Civic Software upgrade to not exceed \$10,000.

The City will not endorse nor prohibit the City Wide Rummage Sales on June 13. Individuals can make their own decisions on this.

Incoming funds to the Chamber have been greatly reduced as many of our members are struggling during the COVID-19 crisis and our focus has been on keeping our businesses open while supporting our citizens in the community through activities such as Grocery Delivery for at-risk citizens and organizing the Community Meal on May 22nd."

"And with the expansion of the parking at Stoughton Trailers," Lowery continues, "the venue must occur at a different location, which would make social distancing challenging. At the end of the day, we understand the most important thing is the safety of our residents. Of course, everyone is disappointed."

The fireworks will be back in 2021 and will be much better! Plan-

ning has already begun to bring an incredible display of fireworks along with a host of family-friendly activities in Putnam Park with our covered bridge in the background. "The celebration will be a great family-centered event with host of family activities sure to create lasting memories," said Lowery. "It will be a blast!"

The Covered Bridge Days is still scheduled to take place in August 2020, but with impact of COVID-19, it may look a little different this year. Covered Bridge Days takes place throughout Brodhead on Friday, Saturday, and Sunday August 7th-9th, 2020. 

Fill your pantry with home-preserved foods

Rest easy knowing you have weeks of food available for your family in your home pantry. Learn safe and easy ways to preserve foods through a series of free, online workshops by University of Illinois Extension. Extension educators will show the latest techniques for canning, freezing, dehydrating, and fermenting a variety of foods safely at home.

Following these simple food preservation steps and you'll be filling your pantry shelves with food you know is safe and healthy for your family.

Parkview Board of Education looks to temporarily fill vacancy—Parkview Board of Education member Don Bomkamp has resigned his position on the Board effective May 12, 2020. Bomkamp showed a strong commitment to the kids, the staff and the taxpayer and will be missed.

The Board is looking for an individual interested in temporarily filling the vacancy. The requirements to serve on the School Board are:

1. 18 years of age or older,
2. A full-time resident of the district, and
3. Not be convicted of a felony or a misdemeanor involving a violation of public trust (A 1996 WI constitutional amendment prohibits a person who has been convicted of a felony for which they have not been pardoned, or who has been convicted of a misdemeanor involving a violation of public trust for which they have not been pardoned, from holding a state or local office.)

If you are interested in temporarily filling this vacancy, please send a letter declaring your interest that includes A) Reasons for wanting to be on the Board and B) Your qualifications for serving on the Board.

The individual appointed by the Board would temporarily fill the vacancy until the next election on April 6, 2021. The appointed individual would have to file prior to the January 2, 2021 to have their name appear on the April 6, 2021 ballot. Grave markers at Greenwood Cemetery

The recent pandemic has affected many things locally including our annual Memorial Day program. But this did not stop our local veteran organizations and auxiliary from putting the flags on our fallen veterans and members. While putting flags out this year notice was made of some of the many different types of markers that can be found in our Greenwood Cemetery. Below are just of the different organization markers that can be found. We know there are many more to be seen so maybe take a walk through the cemetery and make note.



The Knights of Pythias is the first fraternal organization to receive a charter under an act of the United States Congress. It was founded by Justus H. Rathbone, who had been inspired by a play by the Irish poet John Banim about the legend of Damon and Pythias.



The Grand Army of the Republic (GAR) was a fraternal organization composed of veterans of the Union Army (United States Army), Union Navy (U.S. Navy), Marines and the U.S. Revenue Cutter Service who served in the American Civil War.



The Woman's Relief Corps was founded in Portland, Maine in 1883, but chapters quickly appeared in other states, including in Ohio. The purpose of the institution was to provide housing and aid to destitute or ill women nurses from the American Civil War.



The Daughters of the American Revolution (DAR) is a lineage-based membership service organization for women who are directly descended from a person involved in the United States' efforts towards independence. A non-profit group, they promote historic preservation, education, and patriotism.



The Loyal Order of Moose was founded in Louisville, Kentucky, in the spring of 1888 by Dr. John Henry Wilson. Originally intended purely as a men's social club, lodges were soon founded in Cincinnati, Ohio, St. Louis, Missouri and Crawfordsville and Frankfort, Indiana.



Royal Neighbors of America Back in 1895, women couldn't vote and in many states couldn't control their money or own property. Neither they nor children were considered insurable. But our founders believed women have emotional and financial worth. They believed both men and women needed financial protection through insurance. They believed strong women create strong families and then strong communities. So, nine strong women banded together. They didn't just socialize...they mobilized. They formed Royal Neighbors as one of the first carriers to insure women and children.

- Beginning Monday, May 11, cloth masks or face coverings must be worn by all patients, visitors, and staff members at Monroe Clinic facilities

Scheduled patient visits and procedures have been evaluated on a case-by-case basis since early March at Monroe Clinic as a proactive measure to minimize risks and ensure patient safety.

The Supplemental Nutrition Assistance Program and COVID-19

The Feeding America network of food banks will continue to need additional food and funds from the government to help meet increased need, but the single most important thing we can do to put money into the hands of people who need to purchase food is to increase SNAP benefits by 15 percent.

What is SNAP? The Supplemental Nutrition Assistance Program (SNAP), formerly known as food stamps, is the nation's first line of defense against hunger in America. Before this crisis, SNAP served 37 million low-income Americans, providing benefits that are timely, targeted, and temporary. SNAP benefits are delivered monthly to eligible participants through electronic benefits transfer (EBT) cards that can be used to purchase groceries at over 239,000 authorized retailers nationwide. For every meal the Feeding America network provides, SNAP provides nine.

Who is eligible for SNAP? SNAP households must generally have a gross income below 130 percent of poverty (\$2,790 a month for a family of four). A SNAP household's net monthly income, or income after deductions are applied for items such as high housing costs and childcare, must be less than or equal to the poverty line (\$2,146 a month for a family of four). 55 percent go to households with incomes at or below half of the poverty line. The vast majority of SNAP participants (69 percent) are children, seniors, or people with disabilities. SNAP benefits phase out as participants get back on their feet, with the average household staying on the program about a year.

Is SNAP efficient and well administered? SNAP boasts one of the highest payment accuracy rates and one of the lowest fraud rates of any benefit program with low administrative overhead. According to the Congressional Research Service, between 2012 and 2014, there was a 1.5 percent fraud rate in SNAP most of which was due to retailer trafficking of benefits. SNAP responds quickly to changes in the economy. During the 2008 recession, SNAP participation grew alongside rising unemployment and fell as the economy recovered.

What impact does SNAP have on the economy? Households typically spend their monthly benefits quickly, making SNAP a particularly effective stimulus in providing quick support to local economies- every dollar in SNAP benefits helps generate more than \$1.70 in economic activity.

Why increase SNAP benefits now? SNAP is an economic multiplier, infusing money into local economies. With unemployment rates skyrocketing, SNAP is also vital to the individuals and families who were already food insecure, as well as newly unemployed individuals. The maximum household benefit varies by household size, with an individual currently receiving a maximum of \$194 a month. We urge an increase in maximum household benefits of 15 percent, increasing that individual's purchasing power to \$223 per month. We also urge an increase of the minimum SNAP benefit from \$16 to \$30 per month.



Rock County PACE application period open

The Rock County Land Conservation Department's 2020 application period for the Rock County Purchase of Agricultural Conservation Easements (PACE) Program, will open June 1, 2020 and will close on August 31, 2020.

The purpose of the PACE Program is to protect and preserve productive agricultural lands in the unincorporated areas of the County through the acquisition of an agricultural conservation easement. Willing, eligible agricultural landowners retain ownership and private use, but the potential future use of their land is limited to the terms of the perpetual easement and may not be developed or subdivided. The compensation for the easement value comes through a combination of allocated federal and county funds and a tax-deductible

donation by the landowner. There is also an option for a landowner to permanently protect their property by agreeing to the perpetual easement terms and donating 100% of the easement value.

The eligibility criteria, application standards and selection process were designed by a diverse committee representing many interests in the county to promote and encourage a strong agricultural economy, intergovernmental cooperation, and a regional land use plan throughout the County.
