Conditions of sale: Katalina Koolies

1) The Buyer agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper grooming and responsible care. This includes keeping this puppy/ dog parasite free and up to date with inoculations, proper nutrition, which consists of a good quality professional feed given at regular intervals, and fresh water available at all times. The Buyer promises to provide a safe environment for the dog, and never allow the dog to roam freely without proper fencing or supervision. The Seller strongly recommends that the puppy/ dog's micro-chip is updated with current address in order to facilitate their return if lost or stolen. Micro-chips may remain under the name of Katalina Koolies if you are happy for us to be the main contact for the dog but all registration costs must be paid for by the buyer.

2) The Seller guarantees this puppy/ dog to be of sound health and temperament at the time of this sale. A health record of all shots and worming dates will be provided by the Seller, and puppy will leave Seller with topical parasite control applied. The Buyer agrees to take this puppy/ dog to a licensed veterinarian of their choice within 48 hours for a physical examination. Should puppy/ dog be determined to be in ill health, the cause of which the Seller is clearly to blame, the dog may, upon a signed written diagnosis from said licensed veterinarian, be returned for refund of the purchase price. The Seller assumes absolutely no responsibility for any further fees associated with caring for the puppy/ dog. No other guarantees are given.

3) The Buyer agrees to have puppy/dog PennHIP and Elbows scored before breeding. The buyer also agrees not to breed merle to merle or without first obtaining the full DNA, PennHIP and elbow scores for the intended mate.

They must be clear of all diseases, PennHIP scores are required to be below the breed average 0.5 and elbow scores are to be no higher than a score of 1. All scores must be shown to breeder before mating can commence, any information/ scores shared with the breeder will not be published and are for their records only. The Buyer of this puppy/dog should not breed this dog any earlier than 18 months of age. If breeding is not required, the dog can be left intact until such point it becomes a health issue.

- 4) If at any time the Buyer can no longer retain possession of this dog, the Seller is to be notified and given option of resuming full ownership of dog in order for the Seller to locate this dog a new home of the Seller's choosing. Refunds, if any, will be at the discretion of the Breeder/ Seller. The puppy/ dog will be returned with all papers and medical records. Should any circumstances arise that affect the quality of life of the puppy/ dog, the seller/breeder is to be informed of any outcomes. The Breeder/ Seller reserves the right to approve/ prohibit any transfer of this animal to a third party. Under no circumstances will this dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.
- 5) The Buyer agrees to contact the Seller immediately if any questions or concerns arise about this dog, such as housing, diet, or health. The Buyer agrees to keep the Seller informed of any medical issues related to breeding if occurs. This provides the Breeder/ Seller with an opportunity to follow up on puppies and gives us important feedback and information on the health of our dogs for future generations.
- 6) Registration papers will either be provided at time of sale of the puppy/ dog, or transferred to the Buyer immediately upon receipt if they are still being processed. It is understood at the time of sale that this is a breeding quality dog and it is representative of its breed. Training classes are highly recommended for a happy relationship between the dog and family. The Buyer agrees to register the dog using the kennel name of Katalina Koolies.

The preceding paragraphs contain conditions established by the Seller to ensure the wellbeing of the puppy/ dog. The Buyer's agreements will continue for the duration of the dog's life and the Seller will have the right to enforce the agreements.
