- **Medical Emergency Authorization:** The owner accepts full financial responsibility for any veterinary care required for their pet while at **Ohana Pet Resort**. _____
- I acknowledge that vaccines are not 100% effective and that my dog could still get sick. Despite taking precautions and requiring vaccinations, **Ohana Pet Resort** is not liable for kennel cough, as its contagious nature means no guarantee of prevention is possible. _____
- I authorize **Ohana Pet Resort** to seek necessary veterinary treatment for my pet, including transportation, at my full expense if they deem it necessary due to illness, injury, or other symptoms. _____

Assumption of risk and liability:

- I acknowledge, accept, and assume full responsibility and all risks, including but not limited to risks from other dogs, equipment, and facility conditions, associated with my pet's participation in **Ohana Pet Resort** services and understand that my dog may be injured while playing with other dogs, with possible injuries including bites, scrapes, scratches, and sprains, and I agree to be solely responsible for any veterinary costs arising from their stay. _____
- If your pet bites another pet at our facility, **Ohana Pet Resort** is not liable. We will, however, notify both owners and provide information should the injured pet require additional care. _____
- **Release of liability:** I assume all risks of dog boarding and daycare. **Ohana Pet Resort** is not liable for injury, illness, death, or escape, assuming reasonable care is taken. _____
- **Emphasizing owner responsibility:** **Ohana Pet Resort** is not liable for any incidents or injuries involving your dog while on our premises. Despite all precautions, incidents can occur, and the owner is fully responsible for their dog's actions. All disputes and damages must be resolved directly with the affected parties. In these cases, we will cooperate by providing necessary information. _____

Miscellaneous information:

- Your pet may lose weight during longer stays due to increased exercise and different activity levels than at home. _____
- **Ohana Pet Resort** will not board sick pets. If your pet becomes ill while here, even from an asymptomatic carrier like with kennel cough, you are responsible for all resulting veterinary expenses. _____
- **Bite policy:** I understand that if my pet bites a human or another animal, **Ohana Pet Resort** has the right to contact the authorities. _____
