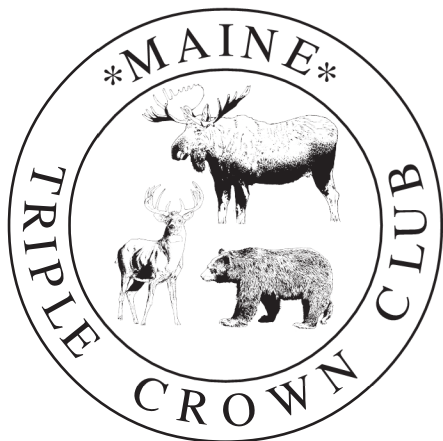
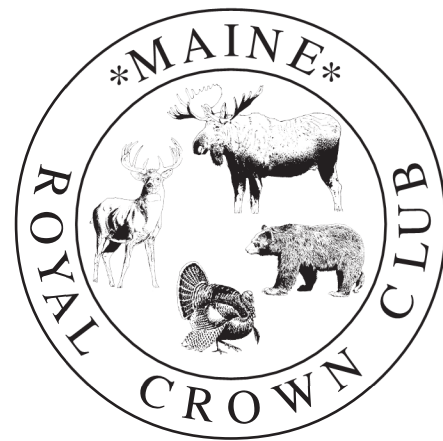

MAINE TRIPLE CROWN CLUB

Established to recognize the rare accomplishment of harvesting three of Maine's big game species for the Triple Crown Club or four of Maine's big game species for the Royal Crown Club in a single year.

Entry Requirements:

1. The individual hunter has to have harvested all three of Maine's big game species (bear, deer, and moose) for entry into the 'Maine Triple Crown Club' or all four of Maine's big game species (bear, deer, moose and turkey) for entry into the 'Maine Royal Crown Club' during a single calendar year.
2. All animals have to be taken by 'Fair Chase' methods in the state of Maine.
3. All big game animals have to be harvested in compliance with all local, state and federal hunting regulations.
4. A photocopy of **all** licenses, transportation tags and permits for each animal **must** accompany the Application Entry Form. If you do not have these items you may contact MDIF&W for copies.
5. A \$25.00 entry fee (payable to MASTC), which covers certificate and special jacket patch, should accompany the Application Entry Form.
6. Photos of all animals (preferably hunter and trophy posed on the ground) should be included with the Application Entry Form to be used in slide show presentation at Awards Banquet and in Record Book.
7. Each animal can be of either male or female gender. (No antler size, skull size or weight limit is required.)
8. Animals may be taken by any legal weapon such as rifle, bow, muzzleloader, or handgun. In case of bear, traps or snares may be used. Crossbows will be accepted with written proof from the Department of Inland Fisheries & Wildlife acknowledging their approval of applicant's use of the weapon.
9. Any big game animal that has been accepted for entry into MASTC's 'Royal Crown Club' or 'Triple Crown Club' and is later determined to be taken illegally or animals entered that were not harvested in the same year will be automatically disqualified from MASTC. Additionally, any other entries that the individual have previously entered in MASTC will be permanently removed from Club records and the individual will be banned from any future entries in MASTC.
10. A certificate and jacket patch will be awarded to the approved applicant at the next Maine Antler & Skull Trophy Club's Annual Big Game Awards Banquet following the acceptance of their entries.
11. MASTC will only accept the original Application Entry Form. You may make a photocopy of the Entry Form for yourself but send the original Application Entry Form to MASTC.
12. The Entry Forms must be filled out completely before MASTC will process the application.
13. Please supply name(s) on Entry Form of an individual(s) who can verify your animals were all taken in the same year.
14. All materials sent to MASTC become the property of the Maine Antler & Skull Trophy Club.
