MEMBERSHIP COUNT

As always, first, let's talk numbers for this last year,...

For the period covering January 1, 2022 through December 31, 2022, we started off the year with 11 chartered lodges and I am happy to report that at this time all lodges are current in their per-capita payments and all are authorized to have representation at this year's Annual Communication.

Falling under the category of encouraging news,...

Our gains for 2022 were 108 which included raisings, affiliations and restorations.

Our loses for 2022 period 86 which included deaths, suspensions and demits.

So, in spite of Covid still looming over us, we actually had a gain of 22 members for 2021 for a total 2022 ending membership count of 1616. We have seen an upswing for 4 of the last 5 years after we were hit hard with many lodges culling their membership list in 2020.

A full membership report including individual lodge membership counts will be published along with the proceedings of this Annual Communication when they come out.

GROUPABLE ON-LINE MEMBERSHIP SYSTEM

Groupable:M2 continues to evolve adding more features to make our lives as secretaries even simpler and reporting more accurate. Their 3 products, Groupable M2: (the membership system), OLP (Our Lodge Page lodge web site) and Passport (the virtual dues card system all work together with each other and sync most of their information automatically.

But going to a virtual dues card system this year has been our biggest advancement by far. To use them, the app called Groupable Passport can be downloaded for either the Android or iPhone.

It also has the ability to utilize a bar code or QR code to be scanned for membership status verification along with helping you pay lodge dues on-line. While this is now our primary method of distributing dues cards, a physical dues card can still be requested from your lodge secretary if you are traveling to a jurisdiction that does not recognize virtual dues cards yet or if you are unable to use this new system with your smart device.

As with anything new, there may be a few ways to do something a little better or display things in a different manner, but rest assured, Groupable is continually working with their jurisdictions to help make a better product.

I write to you on behalf of Masonic Charities of Hawaii (MCH), a non-profit corporation approved under §501(c)(3) of the Internal Revenue Code, making it eligible for tax-deductible donations. It has been my privilege to serve as a member of the board of directors for MCH and be part of its charitable initiatives.

Although separate from the Grand Lodge of Hawaii, MCH receives its funds primarily from Freemasons within our jurisdiction. The Grand Lodge maintains oversight over MCH activities, but it does not run the corporation. MCH was initially formed to fund and operate the Keiki I.D. program as part of a national Masonic initiative called CHIP. However, due to privacy considerations, the program lost its purpose.

In 2016, we decided to revamp MCH's organizational structure, creating a new, smaller board of directors and amending our bylaws. With these changes in place, we are now seeking another charitable purpose. We have many good ideas on how to make MCH more impactful in our community and promote Masonry among our citizens.

As of January 31, 2023, MCH's bank account holds \$36,273.03. Once our purpose is redefined, we will be looking into investing our funds in higher-yielding investments. We welcome input from Masonic members and their families, and we encourage anyone who wishes to contribute to our cause to contact us.

I would like to express my appreciation for the opportunity to serve as a member of the board of directors for MCH. It has been a pleasure working alongside dedicated individuals who are committed to making a difference in our community.

In closing, I extend my sincere gratitude to you, Most Worshipful Sir and Brethren, for your continued support of MCH and its endeavors. Together, we can make a positive difference in the lives of those around us.

REPORT OF THE JURISPRUDENCE COMMITTEE ON MASONIC TRIALS AND EXPULSIONS

Masonic trial against Brother David A. Floirendo

A trial master was appointed (reference Masonic Trial 2022-01) and after due diligence and strict adherence to our Hawaii Masonic Code, he rendered his findings and delivered his decision. The violations had to do with significant financial discrepancies and not filing taxes appropriately, with respect to Brother Floirendo acting as lodge Treasurer of Leeward Lodge.

Most Worshipful Edde T. Kanai, Grand Master of the State of Hawaii reviewed the findings of the trial and agreed to the conclusions of the trial master as well as the penalty that was suggested.

On January 1, 2023, Brother David A. Floirendo was expelled from Freemasonry, in accordance with our Hawaii Masonic Code and was no longer entitled to any rights, benefits or privileges of a Mason.

It was regularly moved and seconded to codify the Grand Master's decision to expel Brother David A. Floriendo. Motion was carried.

Removal of 7 members from the rolls of Masonry from the Grand Lodge of Hawaii

It was discovered by the Grand Lodge of Hawaii that Tony Arruda; Dennis Carter; John William Elliott; Daniel Gleason Kelley; Joseph Edward Miller; Oscar Caalin Tuano; and Cyrus H. Wilson had joined a new Prince Hall Masonic lodge created in Hilo, without first renouncing their membership in Free and Accepted Masonry. They also failed to notify their lodge and the Grand Lodge of Hawaii that they had done so.

After confirming that these individuals had done so, and as they had voluntarily done so of their own free will and accord, Most Worshipful Edde T. Kanai, Grand Master of the State of Hawaii, proclaimed in Grand Master's Decision 2022-03, that they be removed and withdrawn from membership in the Grand Lodge of Hawaii F&AM, as well as any lodge in our jurisdiction they may be a member of along with the expunction of all the rights, benefits, privileges, and titles that come from any connection with said membership.

It was regularly moved and seconded to codify the Grand Master's decision to expel and remove Brothers Tony Arruda; Dennis Carter; John William Elliott; Daniel Gleason Kelley; Joseph Edward Miller; Oscar Caalin Tuano; and Cyrus H. Wilson from the rolls of Masonry and expel them. Motion was carried.

THE KNOWN BASED ON THE SURVEYS:

- Brother Johnny Arias of Los Angeles has a great saying that should be remembered: "focus on the stairs, not the chairs." People today are busy, and time is precious. And the lodge has to be a place of experience more meaningful than that of the humdrum of everyday life, not a part of it.
- If lodges provide that kind of value, members will remain and give back to lodge culture by taking the chairs or taking on other
- Fortuitously, we know who we are and what we want. As noted, according to Ruark's survey results, nearly 90% of brothers consider Masonic education to be either important or very important. Over 90% of consider themselves between moderately or very spiritual. And over 90% appreciate the camaraderie of the lodge. From that survey, it is clear that we need to focus on

 - One, understanding the mysteries, symbolism, and history of Freemasonry, and understanding ourselves.

 - The essence of the Craft must once again become the focus. To that end, each Mason can contribute his skills and talents, and can be an active part of the legacy that we leave for our descendants.

GOOD MEN = GOOD MODELS





- THE MAN PARENTING PROBLEM AND EDUCATION/MORALITY
- Men face many serious issues that society does not want to acknowledge. Over the last century, men have found
 themselves increasingly lacking positive male role models. According to the National Center for Educational Statistics,
 77% of teachers at public schools are female (up from 75% around a decade ago).
- In the USA, where almost half of all marriages end in divorce, a majority of mothers are granted custody of their children.
- A large population of men come from families where the father frequently worked late, was emotionally disengaged
 from his son(s). Some had fathers who were emotionally or physically abusive (or both). Alcohol, gambling, infidelity
 may also have been involved. They could not impart knowledge, wisdom, or a sense of dignity that young men need.
- The reality of modern society is that despite social media or identity politics, people feel more isolated and lonelier than ever before. Dubbing it a "loneliness epidemic," Psychology Today noted in 2018 that "rates of loneliness" have doubled over the last fifty years, and report that 20% of Americans say that they "rarely or never" feel close to other people. As author and journalist Johann Hari stated, "people's sense that they live in a community, or even have friends they can count on, has been plummeting."
- DON'T confuse fraternity, Brotherhood or camaraderie with Cigar and Alcohol Nights. There must be a VALUE to the BROTHER attending LODGE.

BROTHERS FOR BROTHERS


- Currently, in New York City, there is an initiative called "Brothers for Brothers." The program, according to its founder, Brother Teodorescu, "offers an internal platform for Masons to foster, develop and enhance the qualities of well-rounded upright men through mentorship and knowledge sharing." Presentations on practical life skills are to be given for members of the Masonic fraternity free of charge.
 There is also an opportunity for Brothers to speak with the presenter on a one-to-one basis to discuss
- There is also an opportunity for Brothers to speak with the presenter on a one-to-one basis to discuss
 the issue on a more personal level. Subjects include developing communication skills, personal and
 professional development, developing confidence and self-esteem, health and nutrition, bookkeeping,
 and developing appropriate business attire and grooming skills.
- Although these are skills that would take a considerable amount of time or money to acquire, Bro.
 Teodorescu remarked that "the response and reception of the program, and its long-term potential to
 develop Master Masons within our ranks, has been exceptional." It provides a tangible benefit to
 members of the fraternity. It also promises to provide a benefit to the fraternity itself. As Bro.
 Teodorescu stated, our members are "ambassadors" for the fraternity.

GOOD MEN = MASONIC MODELS





- Currently, According to Ruark's survey, nearly 90% of members believe masonic education is either important or very important. However, 65% of members say that their Lodge provides Masonic education between sometimes and never. Additionally, he discovered that the nearly one-in-four members who weren't satisfied, or who were perhaps dissatisfied, with their Masonic experience were in those Lodges.
- Masonic Education needs to RELATE the STORIES of our CRAFT to the REAL WORLD and become PERSONAL.
- We don't want to hear about dogmatic info on what brotherhood is. Instead we DO want to be inspired by a sincere talk about a wartime experience that illustrates the Masonic values of brotherhood, of facing danger, mortality, and what illustrates our potential and capacity to endure or to overcome by a war veteran or active service member!
- LEADERS NEED TO PAIR TOPICS AND BROTHERS WITH SPECIAL INFO AND GUIDE THE DEVELOPMENT OF SHORT TALKS OR PAPERS OR BOTH!
 Who will be a LODGE LEADER for EACH LODGE?
- Why do lodges with ten or twenty active members find it so difficult to put on Masonic education?
 - Simply, public speaking is America's number one fear.
 - In Compact Lodge in New York City, newly initiated, passed, and raised brothers are asked to give a short presentation. After the Entered Apprentice or Fellowcraft degrees, the talks are just a few minutes long, and are generally a personal reflection of the experience. After the Master Mason degree, the talk is roughly 15 minutes, focusing on some area of interest. The point is to get brothers comfortable with speaking in lodge and to be able and willing to contribute to the lodge and to its Masonic education later on.

• In an age when more people consider themselves "spiritual but not religious" and are seeking life's profound truths, we need to embrace the mysteries of Freemasonry and not, as has been the case over the last few decades, present our fraternity as having "no secrets" or as being merely a charitable club. It is a society with symbols, mysteries, profound depth, and a history and a lineage evocative of medieval craftsmen's guilds.

GOOD MEN = SPIRITUAL MODELS



SPIRITUAL EDUCATION AND ENVIRONMENT

- When asked about how active they were in their religion, only slightly over 13% of members considered themselves very active. However, nearly 37% of Masons consider themselves very spiritual. In fact, according to Ruark's data, over 90% of the fraternity considers itself somewhere between moderately and very spiritual.
- The fraternity would seem to be loosely comprised of those who regard themselves as both religious and spiritual, and those who regard themselves as spiritual but not religious.
- In America, these two groups constitute 75% of the population, though the RELIGIOUS group appears to be in decline while the SPIRITUAL/NOT RELIGIOUS group is currently growing.
- According to the Pew Research Center, between 2012 and 2017 the percentage of Americans who described themselves as "spiritual but not religious" rose from 19% to 27% of the population (an eight percent rise). During the same period, however, those describing themselves as "religious and spiritual" declined 11% from 59% to 48%.
- Chuck Dunning, author of Contemplative Masonry, said that those identifying as spiritual but not religious "tend to see the development of personal wellness as a significant element of spirituality."
- Bestselling author Dan Brown told The Associated Press, "I have enormous respect for the Masons. In the most fundamental terms, with different cultures killing each other over whose version of God is correct, here is a worldwide organization that essentially says, 'We don't care what you call God, or what you think about God, only that you believe in a god and let's all stand together as brothers and look in the same direction'."

Most Worshipfuls, Right Worshipfuls, Very Reverend and Honorable Sirs, Worshipful Sirs, and Brothers All,

Good afternoon! Thank you all for attending the Grand Lodge of Hawaii's Annual Communication. I am deeply humbled to stand before you today, and am honored to be your Brother. This has been one of the best experiences of my life, and I am proud to have represented the Grand Lodge of Hawaii and you, in my travels throughout the world to spread Brotherly Love with our other Masonic brethren.

PROPOSED RESOLUTIONS AND JURISPRUDENCE REPORTS

2023 ANNUAL COMMUNICATION

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023-01

Udpate Requirements for 990n Filings

While the mandatory filing of a lodge's 990n is referenced in our Hawaii Masonic Code to wit;

§2546. DUTIES OF TREASURER. It shall be the duty of the Treasurer:

6th To file all required State and Federal reports and returns including but not limited to the State of Hawaii annual registration and the Federal 990N.

§2548. DUTIES OF SECRETARY. It shall be the duty of the Secretary;

11th To verify to the Grand Secretary in the manner prescribed by him that the lodge has filed all required State and Federal reports and returns in a timely manner, within 30 days after the filing thereof.

Many lodges have had the tendancy to ignore this responsibility whether it be from anything from a lack of knowledge to just outright ignoring this adminsitrative requirement. Some lodges have even notified the Grand Lodge that they ineed have filed only to find out later that it actually wasn't.

Because of this we have had several lodges over the year lose their Tax Exepmt status and one lodge in particular has lost their Tex Exempot status twice. Not only does it take a lot of time and effort to reestablish this status but it also creates an issue for the rest of our lodges as we operate under a Parent and Subbordinate organization with the Internal Revenue Service wherein we are all connected. So, when there is an issue with one lodge, it sends a red flag to to the IRS to scrutinize all EIN's that are connected.

This resolution proposes to standardize the practice of filing our 990n's to create consistency on how we handle these filing obligations from year to year...

NOW, THEREFORE, BE IT RESOLVED that section §2548 of the Hawaii Masonic Code be amended as follows:

§2548. DUTIES OF SECRETARY. It shall be the duty of the Secretary;

11th To verify report in writing to the Grand Secretary in the manner prescribed by him that when the lodge has filed all a required State and or Federal reports and or returns in a timely manner, within 30 days after the filing thereof accompanied with a copy of proof of filing.

Update Requirements for 990n Filings

TO THE MOST WORSHIPFUL GRAND LODGE OF THE STATE OF HAWAII:

Your Committee on Jurisprudence, to which proposed Resolution 2023 -01 has been referred, reports as follows:

The proponent argues that many lodges have had the tendency to ignore filing the required Federal 990n report with the IRS, due to a lack of knowledge or just outright ignoring this requirement. Some lodges have even notified the Grand Lodge that they had filed the 990n, to find out later that it actually wasn't.

The proponent further argues that several lodges over the past year have lost their tax exempt status and one lodge has lost it twice. It takes considerable time and effort to reestablish and sends a red flag to the IRS with respect to all lodges that operate under the same parent and subordinate organization.

The resolution proposes to standardize the practice of filing the 990n to create consistency throughout the jurisdiction. It also requires that the lodge Secretary provide proof that the 990n was in fact filed with the IRS to the Grand Secretary.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023–02

Updated Procedure For Forfeiture of Applicant's Application Fees

In today's age of technology, more efficient and and quicker methods are available to everyone instead of relying on the USPS mail system. This resolution proposes to give a lodge secretary additional options in contacting a candidate before resorting to the additional cost and time it would take via the United States Postal Service.

NOW, THEREFORE, BE IT RESOLVED that section §2670 of the Hawaii Masonic Code be amended as follows:

§2670. FORFEITURE OF FEES AND CONTRIBUTIONS. If a candidate does not present himself qualified for the Second and Third Degrees within a period of three years from the date of his initiation as an Entered Apprentice, the Master shall direct the Secretary to either

a) reach out to the candidate by telephone; or

b) reach out to the candidate by email; or

and if neither of these two methods are successful, then the secretary shall

c) forward to such candidate either by registered letter or certified mail, with return receipt requested, deposited in the U.S. Post Office, addressed to him at his last known address.

a-Said notice shall advise advising him that unless he shall present himself for advancement, on or before a specified date (at least sixty days in advance) his fees for the unconferred degrees and all of his previous contributions will be declared forfeited.

The foregoing actions shall not be taken by the Master or Secretary, however, until after the Master has appointed a committee of two or more members of the Lodge to investigate and report back to the Master, why the candidate has not presented himself qualified for the Degree or Degrees involved. A candidate thus denied advancement shall be considered only as an Entered Apprentice or a Fellowcraft with the right of applying for the remaining Degree or Degrees, and paying the fees and contributions therefor, subject to investigation and election, the same as any other candidate.

Updated Procedure for Forfeiture of Applicant's Application Fees

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023-03

Clarification and Update of NPD Suspension Procedure

With regards to the process for brothers who are eligible for suspension due to non-payment of dues and in light of today's age of technology, there are more efficient and less expensive methods of communication available to us instead of relying solely on the USPS mail system.

This resolution proposes to give lodge secretaries additional options in contacting a member before a brother is suspended.

NOW, THEREFORE, BE IT RESOLVED that section §2814 of the Hawaii Masonic Code be amended as follows:

§2814. SECRETARY TO SEND NOTICE. In case any member shall have refused or neglected to pay his regular dues during a period of twenty four months commencing at the time the dues become payable pursuant to the By-Laws, the Secretary shall give him 60 days' notice by <u>either e-mail</u>, or <u>USPS</u> mail <u>service</u>, deposited in the U. S. Post Office addressed to him at his last known address, or by <u>personal delivery</u> actual service of notice, duly certified by the Tiler, that unless by the end of December 31st at the end of that 24th month period either his dues be paid, or sickness or inability to pay be shown as the cause of such refusal or neglect, he will be suspended from all the rights and privileges of Masonry.

A letter of suspension will be sent to members who have been suspended for non-payment of dues notifying them of their suspension which is to include in full, sections §2818 & §2820 of the Hawaii Masonic Code informing them of how they can reactivate their membership.

The resolution seeks to add email as an option for the lodge Secretary to notify the brother with a 60 day notice.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the grand Lodge for passage.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023-04

Provides that Lodges May Engage in Commercial Ventures to Raise Funds for Their Own Operations

The proponent of this Resolution seeks to permit lodges to supplement their income by sponsoring or operating commercial ventures to raise funds for their own operations.

WHEREAS, no lodge can sustain any meaningful operations on the basis of dues alone; and

WHEREAS, the Grand Lodge of Hawaii has raised, and will continue to raise, its *per capita* tax on its constituent lodges; and

WHEREAS, without an operating surplus no saving or investment is possible; and

WHEREAS, no lodge has a reason for existence except to serve the community of which it is a part; and

WHEREAS, no lodge can sponsor meaningful public- or community-service projects if it cannot sustain its own operations; and

WHEREAS, no rational person would join an organization which, in addition to dues, demands or continually requests contributions to fund operations and/or projects; and

WHEREAS, it is highly improbable that an organization can attract potential new members without the public visibility afforded by public- or community-service projects; and

WHEREAS, without a means of generating income or attracting new members the demise of a lodge is inevitable,

NOW, THEREFORE, BE IT RESOLVED that the Hawaii Masonic Code be amended by deleting the existing text in its entirety and replacing it with new text as follows (new matter is underscored, deleted material is crossed out):

2070. COMMERCIAL VENTURES. A Lodge shall not sponsor, or by resolution or otherwise sanction, or permit the use of the name of the Lodge in connection with, or for the purpose of furthering any collateral financial undertaking, or commercial venture, whether for profit or not, which shall not have been approved by the Grand Master, nor shall any member of any Lodge be permitted to do so except in his individual capacity, and without the use of the name of the Lodge.

2070. COMMERCIAL VENTURES. A lodge may sponsor or operate a commercial venture for the purpose of augmenting its income over and above member dues and contributions. Such venture shall require the approval of the lodge by resolution at a Stated Meeting and the lodge may openly identify itself with the venture if such is authorized by the resolution. An accounting of all receipts and expenditures shall be made to the lodge at every Stated Meeting following the start of the venture until the venture is terminated.

Provides that Lodges may Engage in Commercial Ventures to Raise Funds for their own Operations

The proponent argues that lodges can no longer sustain meaningful operations on the basis of dues alone. This is partly due to Grand Lodge of Hawaii continuing to raise per capita tax on the constituent lodges. Without an operating surplus, lodges cannot involve themselves in meaningful community service projects or make investments for their future.

The proponent argues that the lack of funds and demands on brethren to continually contribute to projects out of their own pockets hurts the viability of attracting new members. Without a means of generating income a lodge's demise is inevitable.

The proposed legislation seeks to delete Section 2070 in its entirety and replace it with new language that allows lodges to seek commercial ventures.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023-05

Permits a Lodge to Openly Associate Itself with Recognized Charitable and/or Public-Service Organizations

The proponent of this Resolution seeks to increase the favorable visibility of the Fraternity by permitting lodges to openly sponsor, associate or affiliate themselves with recognized charities and/or public-service organizations.

WHEREAS, no lodge has a reason for existence except to serve the community of which it is a part; and

WHEREAS, no organization can be a meaningful contributor to any cause or project if it is not recognized; and

WHEREAS, Freemasonry does not enjoy widespread recognition in the community and, in fact, is largely unknown or misunderstood; and

WHEREAS, the current regulations of the Fraternity do not promote any coherent image and, in fact, seek to hide its identity; and

WHEREAS, the survival and growth of the Fraternity depend upon its favorable public image; and

WHEREAS, a favorable public image can only be created by visible public service and sponsorship,

NOW, THEREFORE, BE IT RESOLVED that the Hawaii Masonic Code be amended by deleting the existing text in its entirety and replacing it with new text as follows (new matter is underscored, deleted material is crossed out):

§2070b. Lodges are forbidden to sponsor, or by resolution or otherwise directly to sanction, or to permit the use of the name of the Lodge in connection with collateral financial undertakings, such as thrift societies and assessment funds for widows and orphans.

2070b. PUBLIC RECOGNITION OF THE FRATERNITY. A lodge may openly sponsor, associate, affiliate or otherwise identify itself with one or more recognized charitable or public-service organizations for the purpose of furthering the mutual charitable or public-service objectives of the organization and the lodge. Such association shall require the approval of the lodge by resolution at a Stated Meeting and shall not become effective sooner than ninety (90) days after approval. During this period the Grand Master may, for good cause given, veto the resolution.

The proponent argues that the lodges exist in part to serve the community of which they are a part of. Freemasonry does not enjoy widespread recognition and is misunderstood by many. The proposed legislation seeks to delete the current wording of Section 2070b and replace it with new language supporting the resolution.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023-06

Provides that Lodges May Sponsor Girls' Youth Organizations in Addition to Sponsoring DeMolay

The proponent of this Resolution seeks to permit lodges to sponsor any or all three Masonic youth organizations in any combination, removing any implied exclusion of organizations for girls.

WHEREAS, Masons established organizations to support and promote the education and development of both boys and girls; and

WHEREAS, current moral trends increasingly recognize the importance of the inclusion of girls in educational and developmental activities and organizations; and

WHEREAS, our current Code appears to emphasize the development of boys to the exclusion of girls,

NOW, THEREFORE, BE IT RESOLVED that the Hawaii Masonic Code be amended as follows (new matter is underscored, deleted material is crossed out):

§2070c. Sponsoring of DeMolay Masonic Youth Organizations: A lodge or its concordant and appendent bodies, by resolution may sponsor a Chapter or chapters of the Order of DeMolay, a Bethel of Job's Daughters, or an Assembly of Rainbow for Girls. Nothing herein shall preclude a lodge from sponsoring more than one organization, more than one unit of an organization or any combination thereof.

Provides that Lodges may Sponsor Girls' Youth Organizations in Addition to Sponsoring DeMolay

The proponent argues that the Masonic family established organizations to support and promote the education and development of both boys and girls. Current moral trends increasingly recognize the importance of the inclusion of girls in educational and developmental activities and organizations. Our current code appears to emphasize the development of boys to the exclusion of girls by not allowing for a lodge to officially sponsor a girls Masonic organization.

The proposed legislation would modify the current section to allow for a lodge to sponsor a DeMolay Chapter, a Bethel of Job's Daughters, or an Assembly of Rainbow for Girls. And a lodge could also sponsor more than one if desired.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023-07

Provides that Lodges May Not Sponsor, Promote or Otherwise Affiliate with Any Credit or Debit Card Activity

The proponent of this Resolution seeks to dissociate lodges from credit and/or debit card activities.

WHEREAS, lodges have little or no expertise with credit card or debit card laws, regulations, operations, risks or safeguards; and

WHEREAS, lodges stand to gain no benefit from any affiliation with companies which provide or service credit cards or debit cards except as customers; and

WHEREAS, Prudence suggests that credit be used for emergencies rather than as a primary source of funding; and

WHEREAS, much of today's advertising promotes credit as a primary source of funding, a position which we would be supporting by affiliating with a credit card company; and

WHEREAS, our current Code does not address debit cards; and

WHEREAS, our current Code permits the use of credit card programs as commercial ventures of lodges under certain conditions,

NOW, THEREFORE, BE IT RESOLVED that the Hawaii Masonic Code be amended as follows (new matter is underscored, deleted material is crossed out):

§2070d. Grand Masters are authorized to approve credit card programs as commercial ventures of prerequisite organizations, provided that the Grand Master's approval first be sought; that only members of the prerequisite organization be participants; that the membership roster of the organization be used only for Masonic purposes; and that no Masonic fraternal emblem, logo, or name of any fraternal organization, sub organization or charity be imprinted or otherwise contained in or on any credit card issued in connection with such program to any Freemason subject to the jurisdiction of this Grand Lodge.

§2070d is hereby repealed in its entirety, the use of credit cards or debit cards as a commercial venture being reserved to the Board of Directors of the Masonic Charities of Hawaii.

The proponent argues that lodges have little or no expertise with credit card or debit card laws, regulations, operations, risks or safeguards. Lodges stand to gain no benefit from affiliating with credit card companies, except as customers. Prudence suggests that credit be used for emergencies rather than as a primary source of funding. Our current code does not address debit cards.

The resolution seeks to completely repeal Section 2070d and reserving it only for the Board of Directors of the Masonic Charities of Hawaii.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

GRAND LODGE OF HAWAII PROPOSED RESOLUTION NO. 2023-08

Formalizing Grand Lodge of Hawaii Investment Committee

The proponents of this Resolution seek to formally create and define the Grand Lodge of Hawaii's Investment Committee.

WHEREAS, while an Investment Committee has been in use and operating under the auspices of the Grand Lodge of Hawaii for some time, there is no mention of such a committee within our Hawaii Masonic Code nor a clarification on how it is determined who is to be a member of that committee or how long their term lengths are; and

WHEREAS, since there is no mention of an Investment Committee they are often mistaken by many for our Finance Committee which is outlined in the Hawaii Masonic Code;

NOW, THEREFORE, BE IT RESOLVED that the following section XXX be added to the Hawaii Masonic Code as well a section §1202 be amended as follows to match. (**New matter is underscored, deleted material is crossed out**):

§1218. COMMITTEE ON FINANCE. The Committee on Finance shall be a standing committee, and shall consist of the following persons and not others; The Grand Master, Deputy Grand Master, Grand Wardens, Grand Treasurer, Grand Secretary and the sitting Masters of each constituent Lodge. The Chair of the Committee on Finance shall be the Deputy Grand Master; provided that, in his absence, the following committee members shall act as temporary chairman at any meeting at which a quorum is present: Senior Grand Warden, Junior Grand Warden, Grand Treasurer, a sitting Master elected by a majority of those present at the meeting.

§12??. COMMITTEE ON INVESTMENTS. The Committee on Investments shall be a standing committee, and shall consist of the following persons and not others;

The Grand Master, Deputy Grand Master, Grand Wardens, Grand Treasurer, Grand Secretary and the sitting Masters of each constituent Lodge. The Chair of the Committee on Finance shall be the Deputy Grand Master; provided that, in his absence, the following committee members shall act as temporary chairman at any meeting at which a quorum is present: Senior Grand Warden, Junior Grand Warden, Grand Treasurer, a sitting Master elected by a majority of those present at the meeting.

§2070d. Grand Masters are authorized to approve credit card programs as commercial ventures of prerequisite organizations, provided that the Grand Master's approval first be sought; that only members of the prerequisite organization be participants; that the membership roster of the organization be used only for Masonic purposes; and that no Masonic fraternal emblem, logo, or name of any fraternal organization, sub organization or charity be imprinted or otherwise contained in or on any credit card issued in connection with such program to any Freemason subject to the jurisdiction of this Grand Lodge.

§2070d is hereby repealed in its entirety, the use of credit cards or debit cards as a commercial venture being reserved to the Grand Lodge Committee on Finance or to the Board of Directors of the Masonic Charities of Hawaii as the Grand Master shall direct. If this proposal is adopted, the Grand Master shall make his direction within ninety (90) days of the close of the Annual

<u>Communication</u>. Further, the <u>Grand Master shall invest only one of the organizations with the authority to decide on the use of credit and debit cards as a commercial venture.</u>

§1202. STANDING COMMITTEES.

The following standing committees shall be appointed by the Grand Master at each Annual Communication just before the close thereof, viz: On Jurisprudence, on Policy and Long Range Planning, on Temple Properties, on United States Constitution Observance, on Finance, on Credentials, on Foreign Jurisdictions, on Masonic History, on Masonic Education, on Ritual, on Masonic Code on Investments, and on Emergency Action. The duties of such committees shall continue during the year thereafter, and shall cease at the close of the next succeeding Annual Communication except as to members of committees whose terms do not end with the close of that Annual Communication.

Formalizing a Grand Lodge of Hawaii Investment Committee

The proponent argues that although there has been an Investment Committee in use at the Grand Lodge level for some time, it has not officially been codified within the Hawaii Masonic Code. Because of this, the Investment Committee is often mistaken for the Finance Committee.

The resolution will add a section to the HMC creating a Committee on Investments and who shall be a designated member of such committee.

There was an erroneous mention to Section 2070d, which was addressed in Proposed Resolution No. 2023-07. This section of the resolution should be removed as such.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

GRAND LODGE OF HAWAII, F&AM PROPOSED RESOLUTION NO. 2023-09

To amend Section 2800 of the Hawaii Masonic Code allowing a Lodge to reduce the annual dues of its elderly members to an amount equal to the Grand Lodge per capita tax.

With increasing frequency we are discovering members who have become incompetent or who are so incapacitated that they are unable to manage their affairs. Payment of lodge dues might be their least concern, and we may discover their circumstances after they have been suspended for nonpayment of dues. A member should not be suspended for non-payment of dues because he is unable to manage his affairs because of illness or old age.

THEREFORE, it is hereby proposed that Part I, Article VI, Section 2810, of the Hawaii Masonic Code be amended by adding a new subsection 2810c, which reads as follows:

§2810c. A lodge may remit the annual dues of a member if the lodge determines with reasonable certainty that the member has become incapacitated or so ill that he has been and is unable to manage his affairs, notwithstanding his failure to request a remission. The remission shall occur retroactively for the period during which the lodge has determined the aforesaid incapacity or illness has occurred, and the lodge shall be entitled to a reimbursement or waiver of the per capita tax attributable to that member for the period of remission. The lodge shall thereafter report to the Grand Lodge the condition of the member and the necessity of the remission of his dues for each of the subsequent years in which remission of dues is granted.

To Amend Section 2800 of the HMC Allowing a Lodge to Reduce the Annual Dues of its Elderly members to an Amount Equal to the Grand Lodge per Capita tax.

Payment of lodge dues might be their last concern and lodges only discover this many times after the member has been suspended for nonpayment of dues.

The resolution seeks to amend Section 2810 and add a new subsection 2810c. A lodge may remit the annual dues of a member if with reasonable certainty they are able to determine that the member has become incapacitated or so ill that he has been and is unable to manage his affairs, notwithstanding his failure to request a remission of dues.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

To amend Article II, Section 7, of the Hawaii Masonic Code by adding language to Subsection b of that section, and by adding a new subsection 7d, concerning the Ancient Landmarks of Freemasonry

Whereas, the Grand Lodge of Hawaii adheres to the Ancient Landmarks of Freemasonry, and all its members, constituent lodges and the constitution, bylaws, rules, regulations and other transactions and business of the Grand Lodge are subject to the Ancient Landmarks;

Whereas, the Ancient Landmarks are certain fundamental attributes or principles of Freemasonry that are ancient and unchangeable, but may be interpreted, defined and described differently in other grand jurisdictions;

Whereas, it would be advantageous and appropriate for the Grand Lodge to specify and describe the Ancient Landmarks as they are understood and defined in this jurisdiction;

NOW, THEREFORE, Article II, Section 7, of the Hawaii Masonic Code ("HMC") is hereby amended as follows:

1. Article II, Section 7, Subsection 7b, of the HMC is hereby amended by adding the language underscored below:

§7b. This Grand Lodge adheres to the American doctrine of exclusive territorial iurisdiction, which is as follows: Whenever there are three or more chartered lodges in any state or territory in which no Grand Lodge exists and there is substantial unity among Freemasons of such State or territory in favor of forming a new Grand Lodge, they have the absolute right to meet in convention, and a majority of them, not less than three, can organize a Grand Lodge for such state or territory; and when once regularly formed, such Grand Lodge has control and government of all Masons and all Lodges of the three degrees, with full and original legislative, judicial and executive power over all Masons and all Lodges within that state or territory, subject to the Ancient Landmarks of Masonry, as described in Subsection 7d hereinbelow; and no other Grand Lodge can in any way interfere with its jurisdiction, establish new Lodges in such state or territory, with the exception of those Lodges under the jurisdiction of the Most Worshipful Prince Hall Grand Lodge of Free and Accepted Masons, of the State of Hawaii, and its Jurisdiction, Inc., or maintain those already established. The foregoing will not apply to the Lodges or the Members of the Lodges of the Most Worshipful Prince Hall Grand Lodge Free and Accepted Masons of the State of Hawaii, and Its Jurisdiction, Inc.

This doctrine applies to the United States and its territories and not to other countries including the Latin countries. This Grand Lodge will recognize only one Grand Lodge and one Prince Hall Grand Lodge in any state or territory, and will regard all others as irregular and clandestine.

2. Article II, Section 7, of the HMC is hereby amended by adding a new Subsection 7d, as follows:

- 7d. The Ancient Landmarks of Freemasonry adhered to by the Grand Lodge of Hawaii, and to which said Grand Lodge, its members, constitution, bylaws, rules, regulations and other transactions and business are subject, are as follows:
 - 1. <u>Freemasonry is a fraternity of men, who are freeborn and of mature</u> age.
 - 2. <u>A requirement of membership in Freemasonry is a belief in the Supreme Being and in an afterlife of immortality.</u>
 - 3. Freemasonry is a moral science taught through ritualistic ceremonies which progress from lower to higher status known as the First or Entered Apprentice Degree, the Second or Fellow Craft Degree, and Third or Master Mason Degree.
 - 4. <u>Freemasons identify one another through secret or esoteric Modes of Recognition.</u>
 - 5. <u>Freemasonry has adopted and utilizes the symbolic legend of Hiram Abiff.</u>
 - 6. <u>Freemasons within a specified jurisdiction are governed by a Grand Lodge, whose chief executive is the Grand Master.</u>
 - 7. <u>Freemasons meet and conduct business in an assembly known as a "lodge", under the authority of a Grand Lodge.</u>
 - 8. <u>Each constituent lodge is governed by a Master, a Senior Warden and a Junior Warden.</u>
 - 9. The Grand Master has the power to make Masons "at sight".
 - 10. <u>Every Master Mason in good standing has the right to attend every</u> regular lodge, subject to exclusion by the Master for good reason.
 - 11. No unknown visitor shall be allowed to attend a tiled (i.e., closed) meeting of a lodge without first being examined and found to be a Master Mason and a member in good standing of a regular lodge.
 - 12. No lodge can interfere in the business of another lodge.
 - 13. The Holy Bible is considered a "Book of the Law", or a history illustrating certain moral and ethical principles, and which shall be opened at every meeting of a lodge of Freemasons.
 - 14. These Ancient Landmarks cannot be changed.

To Amend Article II, Section 7 of the HMC, by Adding a new Subsection 7d, Concerning the Ancient Landmarks of Freemasonry

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

Motion to adopt rules governing the safekeeping and access to the Grand Lodge Plain Text Ritual.

Section 2689b of the HMC provides for the creation of one plain text ritual to be kept at the Grand Lodge office in a secure location. The Ritual Committee has finalized and printed the Plain Text Ritual and proposes the adoption of the following rules pertaining to its safekeeping and access.

Therefore, it is moved that the following rules be adopted by majority vote of the Grand Lodge as applicable to the plain text ritual:

RULES APPLICABLE TO THE PLAIN TEXT RITUAL

- Location. The Plain Text Ritual (APTR@) shall at all times be kept in a safe at the Grand Lodge Office, the combination for which may be changed by the Grand Lecturer from time to time and which shall be known only to Eligible Persons. The safe shall have an electronic (battery operated) combination lock, equipped with a back-up key to be utilized only if the battery dies. There shall be two such keys, which shall be kept by the Grand Lecturer and Assistant Grand Lecturer or one other member of the Ritual Committee.
- 2) **Eligible Persons** are those entitled to legitimate access to the PTR, who are limited to the following: current members of the Grand Lodge Ritual Committee (ARitual Committee@), the incumbent Grand Master and the incumbent Grand Secretary.
- 3) Manner of access. The PTR may be examined and reviewed only if at least two (2) Eligible Persons are present at the same time, at least one of whom must be a member of the Ritual Committee. A log or registry shall be kept with the PTR, and any person examining or reviewing the PTR must enter his name, date, time of access and the portions of the PTR reviewed. Such research shall be limited to no longer than thirty (30) minutes.
- 4) **Use**. The PTR is intended for reference only. If any person has a question concerning ritual, he should address his inquiry to his Officers= Coach, Master or the Inspector assigned to his lodge. The answer to that inquiry shall be researched by the Inspector, transmitted to the Coach and then to the person asking the question.
- 5) **No duplication**. No portion of the PTR may be copied or duplicated by any means. There shall be only one electronic copy of the PTR, which shall be kept in the safe holding the PTR.
- 6) **Violation** of these rules shall be deemed a Masonic offense.

To amend Section 2800 of the Hawaii Masonic Code allowing a Lodge to reduce the annual dues of its elderly members to an amount equal to the Grand Lodge per capita tax.

Many constituent lodges have elderly members who in their advanced age seldom participate in lodge activities and although their financial circumstances do not merit a remission of dues, they find it no longer worthwhile to continue their membership. Some of them request a demit or allow their membership to be suspended for non-payment of dues. Rather than "lose" a valued veteran member, it would seem better to reduce that member's dues, while he continues supporting the lodge by paying the per capita tax incurred for his membership.

THEREFORE, it is hereby proposed that Part I, Article I, Section 2800, of the Hawaii Masonic Code be amended by adding a new subsection 2800b, which reads as follows:

§2800b. A lodge may (but need not) amend its bylaws to provide that the annual dues for a member who has remained in good standing for a continuous period of at least fifteen (15) years and who is at least eighty (80) years of age, at his request, may be reduced to the amount equal to the annual per capita tax assessed by the Grand Lodge attributable to that member.

To Amend Section 2800 of the HMC Allowing a Lodge to Reduce the Annual Dues of its Elderly Members to an Amount Equal to the Grand Lodge per Capita Tax

The proponent argues that lodges have elderly members, who due to their age seldom participate in lodge activities any longer. Because of this, they no longer find it worthwhile to keep paying dues. They many times either demit or allow themselves to be suspended for non-payment of dues.

The resolution seeks to allow a member of a lodge who is at least 80 years old and a member for at least 15 years, to request that the lodge lower their annual dues to that of only the per capita tax assessed by the Grand Lodge.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

To amend Section 1148 of the Hawaii Masonic Code to reimburse the elected Lodge representative for round trip air fare to and from communications of the Grand Lodge.

Under HMC §11 an elected representative of a constituent Lodge is a member elected to represent the Lodge at the next regular or special communication of the Grand Lodge in case none of the Lodge pillars is able to attend. HMC §1148 provides that the Grand Lodge will reimburse the Lodge for one pillar's round-trip airfare to and from any Annual or Special Communication of the Grand Lodge. This proposal would provide for the reimbursement of the Lodge for the airfare of its elected representative, should all the pillars be unable to attend, thereby correcting an oversight in this section of the HMC.

THEREFORE, it is hereby proposed that Part I, Article I, Section 1148, of the Hawaii Masonic Code be amended to read as follows:

'1148. REIMBURSEMENT OF EXPENSES OF LODGE REPRESENTATIVES.

One authorized pillar (or if all the pillars cannot attend, the elected representative of the Lodge) and the Past Masters= representative of each Lodge in the jurisdiction present at either the Annual or a Special Communication shall be reimbursed, by the Grand Lodge, for his round trip air fare from the location of his Lodge in the jurisdiction to the site, for attendance at the relevant communication with an amount that has been approved by the Grand Master. Any further expense to these Grand Lodge Communications is to be borne by such representative or voting officer as approved by their lodge.

Receipts for reimbursement shall be submitted no later than the date of the ending of the Annual Communication for that year as accounting for the Grand Lodge=s fiscal year ends at that time.

To Amend Section 1148 of the HMC to Reimburse the Elected Lodge Representative for Round Trip Air Fare to and From Communications of the Grand Lodge

The proponent argues that Section 1148 currently only allows for the reimbursement of airfare for a lodge representative that is also a pillar of the lodge to attend the Annual Communication. There are times when none of the pillars are able to attend and a representative is elected to represent all voting members, but is not a sitting pillar of the lodge. This resolution would correct an apparent oversight with respect to this section.

The resolution seeks to amend Section 1148 to allow for the elected representative who is not a pillar of the lodge to be reimbursed for their round trip air fare when representing the lodge at an Annual Communication of the Grand Lodge.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. As it intends to amend the HMC, it requires a 2/3 vote of the Grand Lodge for passage.

New Secretary's Proficiency

Proficiency requirements exist in our Masonic code for many different officer but they are primarilly for positions in regards to ritual and not administrative. Over the years it has proven that serious problems are created when a lodge transitions to a new secretary with little or no training and is not prepared for the requirements of that postion.

A lodge's ability to function properly can be severely hampered by a lodge secretary who does not understand the requirements and procedures that this position demands. A poorly prepared secretary cand hinder a lodge so much that it can take years for a lodge to get back on track as there are occasions when problems are not discovered until it is too late to rectify easily.

If there are proficiency requirements for certain officer positions to advance to a postion which is only be expected to be held for 1 year, why isn't there a proficiency requirement for a secretary who is hoped to hold that position for years to come.

As this is a chronic situation year after year, this proponent asks a favorable vote that this legislation be approved as emergent and proposes the follow addition to the Hawaii Masonic Code to put step guards in place sooner rather than later.

NOW, THEREFORE, BE IT RESOLVED that a new section §2521 be added to the Hawaii Masonic Code as follows:

§2521. QUALIFICATIONS OF SECRETARY. Before a brother who has never held the position of Lodge Secretary in this jurisdiction before or one has not held the position for more than 5 years, he must first pass a satisfactory proficiency as prescribed by the Grand Secretary before he can be installed as such. This proficiency is to include but not necessarily be limited to a familiarity with 1) Usage of current membership system; 2) knowledge of procedures such as acceptance of membership applications, annual reporting responsibilities, and communication protocols with other lodges within our jurisdiction and without, and 3) a general familiarity of the Hawaii Masonic Code and how to search its contents.

New Secretary's Proficiency

The proponent argues that proficiency requirements exist in the HMC for certain officers, but is in regards to ritual rather than administrative duties. Over the years, lodges have placed a member in the chair of lodge Secretary, with little or no training. This has caused problems and has sometimes caused a setback that can take years for a lodge to get back on track. The proponent believes that the important position of Secretary should also have a proficiency component to have a safeguard in place and provide important training for someone taking this position.

The resolution seeks to add a new section to the HMC that specifies the qualification requirements for someone seeking to be elected to Secretary of a constituent lodge.

The proposed legislation is in proper form and its subject is appropriate for the Grand Lodge to consider. Because this resolution is emergent and was not submitted within the 120 day period required by the HMC, it will require a 2/3 vote of the Grand Lodge to determine whether it is emergent or not. If the resolution passes this vote, then it also requires an additional 2/3 vote of the Grand Lodge for passage.
