Terms and conditions

These terms and conditions ("Agreement") set forth the general terms and conditions of your use of the "Flash" mobile application ("Mobile Application" or "Service") and any of its related products and services (collectively, "Services"). is deceptive or fraudulent; (iv) content that promotes the use or sale of illegal or regulated substances, tobacco products, ammunition and/or firearms; and (v) gambling, including without limitation, any online casino, sports books, bingo or poker. Any user can flag content they deem objectionable for review. Content will be moderated by Be Heard to ensure the timely removal of all objectionable content. User accounts which have been confirmed responsible for posting objectionable content will be restricted from access to FLASH the app.

User content

We do not own any data, information, or material (collectively, "Content") that you submit in the Mobile Application while using the Service. You shall have sole

responsibility for the accuracy, quality, integrity, legality, reliability, appropriateness, and intellectual property ownership or right to use of all submitted Content. We may, but have no obligation to, monitor and review the Content in the Mobile Application submitted or created using our Services by you. You grant us permission to access, copy, distribute, store, transmit, reformat, display, and perform the Content of your user account solely as required for the purpose of providing the Services to you. Without limiting any of those representations or warranties, we have the right, though not the obligation, to, in our own sole discretion, refuse or remove any Content that, in our reasonable opinion, violates any of our policies or is in any way harmful or objectionable. You also grant us the license to use, reproduce, adapt, modify, publish, or distribute the Content created by you or stored in your user account for commercial, marketing or any similar purpose.

Adult content

Limitation of liability
