The Door County Invasive Species Team (DCIST) is a group of natural resource professionals and interested public members that are concerned about the preservation of Door County's natural environment. DCIST seeks to halt the invasion of exotic, non-native plants by empowering citizens with the education, tools and skills necessary to control invasive species. DCIST is committed to educating, preventing, minimizing, and eradicating invasive plants and reducing their impact on Door County's natural resources, economic viability, and human welfare. The partnership promotes an open exchange of information, public and private sector coordination, and citizen involvement. DCIST has been a model cooperative weed management group for the state, bringing together natural resource groups present in your community, for over 20 years!

In 2022, with the help of various Invasive Species Education and Outreach grants, Cooperative Weed Management grants, Invasive Species Control grants and donations obtained through generous donors such as yourself, the DCIST was afforded the opportunity to:

- Offer training and outreach for invasive species identification and monitoring, participating in over 15 webinar, interviews, and volunteer events. Engaging over 27,000 people through news interviews, media platforms, and one-on-one site visits.
- Promote the adoption of Door County priority/Phragmites ordinances in eleven towns and the city of Sturgeon Bay. DCIST continues to conduct outreach and education within these municipalities to ensure successful ordinance implementation.
- Manage 2 CD3 boat cleaning stations and 2 simplified boat cleaning stations, providing aquatic invasive species prevention tools to over 95% of county boat launch users. Manage 3 boot brush stations along the Ahnapee Trail, and install 7 more on various County Park properties.
- Inventory and control 540+ acres of invasive species.
- Begin updating our strategic plan.
- Participate in Early Detection and Rapid Response Efforts for new invasive species in Door County.
