- Shipping fees are non-refundable, including if the mare does not settle.

### ***Live Foal Guarantee***

If the mare does not settle or fails to produce a live foal, the mare owner may rebreed within two (2) years of the original breeding date.

A live foal is defined as a foal that stands and nurses unassisted and survives for at least seven (7) days after birth.

Mares that do not settle may be substituted with another mare upon approval of the stallion owner. Additional collection and shipping fees will apply.

The mare owner agrees to notify the stallion owner if:

- The mare is confirmed in foal
- The foal is born and meets the live foal requirement
- The mare is sold while in foal
- The mare does not settle
- The mare fails to produce a live foal

Breeder's Certificates and registration paperwork will not be released until all fees are paid in full and a live foal has been reported.

### **Mare Owner Responsibilities**

All veterinary expenses are the responsibility of the mare owner, including but not limited to:

- Mare care
- Insemination
- Ultrasounds
- Collection fees
- Shipping fees

The mare owner is responsible for presenting a healthy mare in suitable breeding condition and capable of carrying a foal to term.

No guarantees are made regarding:

- Foal color
- Foal sex
- Future performance

This contract and stud fee are transferable to another mare only with approval from the stallion owner.
