Borreliosis

A naturopathic therapy of tick-borne borreliosis is worthy of attention

In a medical or naturopathic doctor's office, secondary tick bite diseases often occur and must be treated. The way the therapist approaches this task is dependent on the current factual status, the information level, and the therapist's intuition. Since 1990, I have been able to successfully treat some cases of borreliosis and its secondary diseases in my naturopathic doctor's office.

Case report

Summer 2014: A young man comes into my doctor's office and complains about severe fatigue, lack of energy, and strong joint and muscle pain. During the anamnesis, it turned out that he was bitten by a tick during a forest walk two and a half years ago.



In the bite area, a circumscribed skin elevation of approximately 5 mm could be observed. A friend had tried to remove the tick for a few hours, since the patient himself was not able to remove it at this inaccessible location. Since a red circumscribed area formed later (Erythema migrans, often occurs when ticks are infected with borrelia) at this location and strong itching and causalgia (burning pain) additionally occur-

red, he went to his family doctor. The family doctor found out that the tick was still anchored in the wound in the upper body. After wound care he got a prescription for an antibiotic, and left the doctor's office. He rejected being vaccinated against TBE. At this time, it was impossible to determine the IgM and IgG antibodies in the laboratory. However, he was advised to have the antibodies determined after about a month. He took 1/3 of the pack of antibiotics and stopped the intake, since he had no complaints anymore. Actually, he had some pain attacks or flu-like symptoms in the next few months, but he did not pay special attention to this. However, increasing fatigue and muscle and joint pain gradually became prominent. Sometimes he was not able to keep pace with his colleagues during their sporting activities. Even at his job it was difficult for him to give his full capability. He came into my doctor's office with these symptoms. Since we always like to work together with the patients' family doctors or therapists in my naturopathic doctor's office, I asked the patient to allow the pending lab test regarding his antibodies. The lab report showed a significant deviation from the norm with respect to IgM and IgG. I always advise a lab test prior to a treatment, since my treatment plan can change according to the results of the laboratory test.

A treatment with the TimeWaver Frequency, a device in the field of microcurrent-therapy⁽¹⁾,

followed. During this, the measured values regarding borreliosis and Lyme disease showed a relevance of 97 - 99 % at the beginning of the treatment and thus were an indication of a high burden on the patient.

The duration of such a frequency treatment is individually adjusted to the patient's constitution. In the present case, the initial treatments took about 1 1/2 hours and were shortened to half an hour afterwards. In the first week, three treatments were performed and two treatments each in the second and third week. The treatment was performed weekly starting from the fourth week.

We use plant-therapeutic and orthomolecular remedies for an accompanying therapy; these remedies support the detoxification process and the organs, and include teasel root extracts that are used therapeutically. In order to create an information nosode, we use the technology of the TimeWaver MED⁽²⁾. Since, unfortunately, the tick was not present anymore, we obtained nosodes from urine and sweat that occurred around the bite.

After only two treatments, the symptoms improved. After about three weeks of treatment, the lack of energy was reduced and the sleeping behavior improved. The patient noted more vitality, and again took pleasure in his work and his sporting activities.

Notes

1. First, it should be mentioned that a proper and rapid removal of the tick is very important.

If you give the arachnids too much time, they will deeply anchor in their host. An improperly removed tick, infected with borrelia, releases the pathogens together with its saliva and a transmission of borrelia becomes more likely. For this reason, only suitable tools should be used to remove the tick. Tick cards, that are available in the pharmacy can be kept in the pocket or purse, and are an ideal tool for this purpose. Furthermore, no commenced antibiotic treatment should be stopped too early, since resistances may develop. After the treatment with antibiotics, it is important to provide the intestine with physiological microorganisms. I like to recommend products of the company Ardeypharm with Mutaflor and Paidoflor or use Vitabiosa simultaneously.

2. After removing the tick, take it with you to your therapist. A well-trained and equipped physician or medical practitioner is able to produce a detox nosode. This allows a very efficient drainage of harmful toxins that found their way into the organism through the tick.

3. Many naturopathic colleagues and doctors reject a tick vaccination, but if this is done, the experienced therapist is able to produce an appropriate detox nosode which can cleanse the body from any remaining protein fragments and/or carrier materials.

Conclusion

The naturopathic therapy of tick-borne borreliosis is significant. A detailed medical history is necessary in order to obtain a complete overview. The use and involvement of technical aids is diagnostically and therapeutically absolutely valuable.

The course of treatment, exemplarily shown here, is also used for many of my other patients having similar symptoms.

1. The device, with medial class 2A, belongs to a new generation of complementary medical equipment. By means of a comprehensive analysis, the deeper background of the individual problems that superficially occur on the symptomatic level - here borreliosis infection - might

be detected. This therapy method is intended to support the body's own regulatory mechanisms in a wide range of applications. This form of frequency therapy is intended to act at the cellular level and should be used for the treatment of the cellular milieu and the mitochondria. Additionally, it should support cellular communication, metabolism, and a healthy cell membrane potential. The frequency therapy includes frequencies in the range from Hz to Mhz. These frequencies are determined either automatically or are entered manually.

2. The TimeWaver Med, operating on a quantum physical level, belongs to new generation of devices that are gradually coming into people's awareness, based on the science of the quantum physical sector. By means of its quantum physical interfaces, it should be possible to transfer balancing information and vibrational patterns into a person's information field in order to create a newly ordered field that enables the modification of previous conditionings in the physical, mental, and emotional areas.
