I, the undersigned, hereby apply for membership with the Powell County Shooting Association (Hereinafter referred to as the Association). Upon being accepted, I assume full responsibility for my actions pertaining to the use of firearms and related equipment while using the Association's range (Hereinafter referred to as range or facility). I have received and read the current Range Use and Safety Rules, and I guarantee that I am fully aware, understand, and will abide by all range and safety rules. Further, I am aware that any disregard on my part for any range rules could result in action by law enforcement and could put my membership in jeopardy. I acknowledge that the use of and competition with firearms is inherently a dangerous sport, that I am familiar with the risks involved, and that I willingly and knowingly accept these risks. I hereby agree to hold harmless from and waive any and all claims for property damage, personal injury, death, or any other claim against and as to the Association, all of its officers, directors, members' employees, agents, servants, volunteer helpers and all other participants. This agreement is entered into by me upon my becoming a member of the Association, and is binding on all my heirs, assigns and successors in interest.

**RANGE USE AND SAFETY RULES**

**1. SAFETY FIRST:** The safe handling of firearms is the responsibility of everyone on the range! Be cautious and considerate of others. Consumption of alcohol, drugs, or other mind-altering substances legal or illegal before using or while on PCSA property is strictly Prohibited!

**2. COLD RANGE:** Firearms must be unloaded and magazines removed unless on active firing line. An unloading/loading barrel is provided at the entry gate to clear and load carry firearms. Active-duty Law Enforcement officers are exempt.

**3. HEARING and EYE protection** must be worn on or near an active bay by all persons.

**4. FIRING LINES:** All shooting must be done from the benches or established firing line.

**5. CEASE FIRE:** All firearms must be unloaded, magazines removed, and actions open or flagged while anyone is down range. Absolutely No handling of firearms!

**6. It is strictly prohibited for anyone to be behind the target frames, dirt backstop or on any berms.**

**7. FULL AUTO FIREARMS:** Only tripod mounted or tethered full auto firearms are permitted.

**8. TARGETS, AMMUNITION, DEBRIS:**

- Place paper or cardboard targets on backer boards away from support post and frames, and directly in front of backstop.
- **Metal Targets are prohibited on lower pistol bays!** On other bays, self-provided, steel targets must be placed at a minimum of 25yd (75ft) for Handguns, Pistol Caliber Carbine, and .22 Rim Fire. For High Power Rifles steel targets must be placed at a minimum of 100 yd.
- **NO shotgun shot or slugs on range backer boards.** Bring your own targets (NO ariel targets) & stands for shotgun use.
- **NO:** Exploding targets, Incendiary, Steel Jacket or Steel Core ammo.
- **Police your used targets, trash and brass.** Trash receptacles are provided.

**9. Cigarettes or Cigars:** If you smoke, please do so carefully. Do not leave butts on the ground and make sure they are out before placing in the trash.

**10. PROHIBITED ACTIVITIES:** Camping, Open Fires, or Hunting is not permitted anywhere on the facility.

**11. Pets are to remain in your vehicle.**

**12. MEMBERSHIP:** Membership includes Yourself, Partner/Spouse and legal dependent(s), (dependent(s) must be less than 19 years of age), all of whom must reside at the same address. All persons under the age of 19 must be directly supervised by an adult range member.

- **Membership run from January 1<sup>st</sup> to December 31<sup>st</sup>. Memberships are not prorated.**
- Membership forms may be obtained from a current Range Board Member or an authorized sale source as listed on the PCSA website, <https://pcsamt.org/membership>
- **It is strictly prohibited to Loan or Duplicate the Range Key or Lock Combination.**

**13. Guests:** Guests are welcome when accompanied by a current range member.

- **Each Guest must complete and sign a Guest Liability, Waiver, & Rules form, and pay a guest fee for each visit.** Forms are available in the Guest Box located inside the front gate or on the PCSA website, <https://pcsamt.org/membership>.
- Signed and Completed form(s) along with payment are to be deposited in the Guest Box located inside the front gate.

**14. RANGE HOURS:**

- 9:00AM – 8:00PM Monday – Saturday, **April 1<sup>st</sup> – September 30<sup>th</sup>**
- 9:00AM – 5:00PM Monday – Saturday, **October 1<sup>st</sup> – March 31<sup>st</sup>**
- **9:00AM – 1:00PM SUNDAY YEAR-ROUND.** Please help us keep the neighbors happy.

**15. ENTRY GATE:** The Entry Gate must remain **CLOSED** and **LOCKED** upon every entrance and exit from the range.

**16.** If you are the **First** or **Last** person on the range, the “Hot Range Flag” located inside the gate need to be **Raised** or **Lowered**.

**17. EXCEPTIONS & VIOLATIONS:** At the discretion of the PCSA Board of directors’, special use activities or exceptions to the rules may be allowed. Any violation(s) of these rules may result in loss of range membership per the PCSA bylaws. Member(s) may/will be held liable for their own or their guests’ actions damages and possible legal action through law enforcement.
