  - Should No-Sting Rec become buddy draft/social every season, and only No-Sting Intermediate for premade teams (with 5 Adv player max per team) and possibly disproportionate skilled teams?
    - This would go into effect starting Winter 2026
    - Buddy draft for Rec sounds great
      - Allows a great way for players to meet new people
    - Intermediate would still have "guidelines" for how teams set up
      - Probably do buddy draft for Intermediate once a year
  - Rec Dodgeball Skills & Drills during Skills & Drills
    - Finding someone to lead it?
    - Eli and Sloan will ask players
  - o Foam
    - Advanced goal of 42
  - Trying to have everything set up before open-gym, so teams can play with their teams.

- Using a Go-Pro to record one court a week and have it posted to Summit YouTube
