- Finance Updates
  - B & Steph will present on registration and finance numbers
    - Are beginning to analyze the data and trying to understand what is needed to make sure our leagues can be successful
    - Building out an SOP for expenses, budgets, etc.
      - There is a reimbursement form for receipts.
        - Eli to test the form
        - o B & Steph to review before posting
    - Also looking into the minimum requirements for making our leagues successful and in the positive
  - We are moving away from Venmo and will transition to credit card readers through our bank.
  - Working on what finance transparency can look like for the board and our members
- Have we looked into not using Citywide Sports and instead go directly with Parks & Recreation.
  - Andrew's experience from managing Kickball, it was cheaper to go through Parks
     & Rec instead of through Citywide Sports.
  - Kristen will connect with Parks & Rec to see what is possible.
- 2026 Registration Fees Increase (for all sports except Climbing)
  - This is based on an 8 week season sport. Prices for a different timeframe would proportionally reflect these fees.
    - IE. a 4-week sport would have...
      - Early bird \$30 first 2 weeks of registration
      - Standard \$35 middle time period
      - Late \$40 last 7 days of registration
  - Virtual Vote conducted this week
    - Early bird \$60 first 2 weeks of registration
    - Standard \$70 middle time period
    - Late \$80 last 7 days of registration

- 2026 Registration and Payments for BOD/LM/LR

- Discounted Registration as a thank you for the work that goes into making Summit successful..
  - Board members
    - Free registration to all divisions
    - No guest star fee
    - Do not get paid for reffing
  - Division Managers
    - Free registration to the divisions they are managing, 50% off to any additional division
    - No guest star fee
  - Division Representatives
    - One free registration to use for the division they are managing or other (their choice,) 50% off to any additional division
    - No guest star fee
  - Additional discounts
    - Set-up crew?
      - No more "free season" set-up crew. The first division that plays will rotate teams to help set up.
      - If a member reaches out for financial assistance, set-up crew can be an option for a discounted season.
    - Season awards?
      - Yes, one Sportsmanship Award given out to one person per division for a free season code
- Payment structure
  - o Board members do not get paid this is a volunteer role
  - Managers & Division reps get paid \$5/registration
    - Managers & Division Reps will split the \$5/registration
      - \$2.50 per registration to manager, and \$2.50 to rep
  - B will look into if we can create an incentive for higher registration amounts for a "bonus" for DM/DR
- 2026 BOD timeline Gaelen
  - All Board Members will serve a minimum one-year term with the option to extend for up to three-years total with vote approval by the ELT. To extend their term, Board Members need to notify the ELT before 60 days of their annual term ending.
    - April 30, 2026
    - **■** ALL Director positions
    - If you are planning to step down at the end of this year's term, the sooner we know, the better we will be able to plan.
  - Members of the ELT are required to serve a minimum of two years with the option to extend for up to three-years total with vote approval by the BOD. A passing vote is met with a 65% vote of eligible members. This does not include the individual of which we are voting on.
  - Board Members are welcome to re-apply to their position at the end of their three-year team for another three year term. They will be considered along with any other candidates that apply.

## End of Year Gala Updates, Requests, Support (6:55 - 7:15) Quinn to add any updates here

  - Set up begins at 2 PM
  - o Doors Open at 7 PM
  - o 7-8 PM Social Hour
  - o 8-8:30 Awards
    - Board presence requested
  - o 8:30 9:30 Social Hour
  - o 9:00 9:30 Tear down
  - o 9:30 PM We have to be out of Glow
- Budget Breakdown = Approx \$2,000
  - $\Rightarrow$  Bar Minimum = \$800 + 25% Gratuity = \$1,000
    - Gratuity is only charged for what we pay
  - Food Estimate = \$750
    - Price is for a taco bar that feeds about 50 (full meals). Do we need food? Would it be better to use money to cover more drinks? Would love some thoughts here
  - Awards = \$100 vp@summitsportsleague.com is this reasonable?
    - Alternatively, we could seek out 3D printed ones somewhere too?
    - Looking into Summit community members to make the awards
  - Miscellaneous Supplies = \$150
- Tickets
  - \$30 / pp through end of november. Final two weeks, tickets increase to \$40 / pp
  - Ticket Goal = 60 80 people
    - Break even point is roughly 65 individuals
    - Capacity is "legally" limited to 129
  - Current Ticket Sales = 20 tickets (if all board signs up, we will be at 30)
- Drinks
  - o Intent is that the ticket includes a welcome drink/ticket. X Bar doesn't really have a system set up for this, but here are their options for pricing since they don't have a "menu".
    - $\blacksquare$  Wells = \$8
    - $\blacksquare$  Calls = \$10
    - $\blacksquare$  Top Shelf = \$12
  - If we use the above pricing, I would recommend that each ticket gets a drink ticket for a call, assuming 80 tickets would mean we'd hit the bar minimum and our total cost would be \$1,000.
    - Option B: each person gets 2x Well tickets. This might push us over on budget depending on final numbers, but something to consider.
    - Alternatively, we can also give a budget and they will tell us what quantity of bottles that provides and they can serve till they run out. Or we can have a signature cocktail made for the event and have that be served as well. Personally, I think drink tickets ensure everyone gets one, keeping options flexible (includes N/A), and hits our tab requirement.

## **Town Hall Discussion** (7:30 - 7:50)

Guest Stars

- Fees do we want to continue to charge subs for playing?
  - B Baker Can you add any finance insight here on what if we stopped collecting guest star fees?
  - \$2,000 in income annually for guest stars which we feel is pretty significant in our budget
- A lot of players use guest stars as a way to play all season long
- Keep guest star fees at \$5 for now, and then reconsider as we move along
  - Which is cheaper than signing up for all season long
  - With new registration fees, guest stars will have to pay \$8.75 every time (for 8 weeks) to match the registration fee
- If someone is trying for the first time, they get a free first guest star option
  - Need to look into how to properly track this
- An idea of a "punchcard" where they can pay \$20 for 5 guest star options
  - Could interfere with regular registration payments/costs
- It's working in Advanced Foam to have an extra one or two players on a team as "subs" to rotate out throughout the night
  - This will alleviate the need for finding guest stars and making sure they have a full team
- Are we sharing the guest-star sign up list with captains?
  - Kristen will work with her teams to make sure they know this is available.
- Captains...
  - Is the captain's guide being utilized and going out to players?
  - Is there a way we can incentivize/thank captains for being one to encourage them to sign up again?
    - 50% off code given at the *end* of the season?
  - A meeting before the season starts? (at open play?) to go over rules, expectations, communication, community, etc.
- Open Plays
  - Can these happen 2+ weeks before a season starts to players can hear about it, be able to sign up, and get ready for the season?
  - Can they happen more in the "off season" as a way to keep people engaged and playing, to meet new players and build teams?
  - B Baker and Kristen Schuster, can you run numbers to just show how much it would be for one day, two hours, at each of our venues?
- REMIX type seasons
  - Feedback was shared about getting rid of skill level divisions and just having everyone play together on mixed teams. Is there a possibility of making teams this way?
- Mentorship Program
  - How can we better support more experienced players wanting to mentor and help support our new players on how to improve?
    - Advanced players be captains (without playing) for rec?
