

SUMMIT SPORTS LEAGUE PARTICIPATION WAIVER OF LIABILITY, COVENANT NOT TO SUE, ASSUMPTION OF RISK / RELEASE / IMAGE RELEASE PLEASE READ CAREFULLY I, the undersigned, hereby acknowledge that participation in athletic activities involves an inherent risk of physical injury. The undersigned hereby agrees, for the sole consideration of Summit Sports League, allowing the undersigned to participate in athletic activities for which or in connection with the league sponsored or made available any equipment, facilities, grounds, or personnel for such activities or to the undersigned while participating in any such programs or activities, the undersigned does hereby release and forever discharge Summit Sports League, its members officially and individually, and its officers, agents, and employees of any and all claims, demands, rights, and causes of action of whatever kind or nature, arising from any injuries, damage to property, and the consequences thereof, including death, resulting from my participation in any way connected with such athletic activities.

Further, in consideration of being allowed to participate in a kickball league, tournament and/or any other related events and activities produced by Summit Sports League, the undersigned:

- 1) Acknowledges the risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) KNOWINGLY AND FREELY ASSUMES ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3) Willingly agrees to comply with the stated and customary terms and conditions for participation. If, however, the undersigned observes any unusual significant hazard during my presence or participation, he or she will remove themselves from participation and bring such to the attention of the nearest official immediately.

In consideration of being allowed to participate in any way in a Summit Sports League athletic program, related events and activities, the undersigned acknowledges, appreciates, and agrees that: The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) from the Activities involved in this program are significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and, I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
