**Seating in class is based on when your application is received. The later we receive it, the farther back in the classroom you will be.**

**As of October 17, 2022, the Licensing Board has gone to “OPEN TESTING”. There is no longer an April Exam, August Exam and December Exam. Once you get Board approval, you may register and schedule with AMP/PSI and take the exam whenever you want.**

**What the new rules mean to you:**

- 1. There is no longer a Licensing Board deadline. You may submit an application at any time.**
- 2. There is no longer a PSI deadline to register for the test. However, you cannot sign up with PSI until they receive your approval from the board office. PSI will notify you by email once they receive your approval.**

Here's what you need to do:

Step 1: Fill out **State Application** and mail to Macon, GA with the application fee. Don't forget to send a **background check, reference letters** and the **Secure and Verifiable Document** (usually a copy of driver's license) with your **STATE** application. Do not send it to GPI!! All of this goes to Macon.

Step 2: Fill out **GPI Application** and mail with **Non-refundable Course Deposit of \$250.00**. The remaining balance of \$750.00 will be due the first day of class plus \$250.00 if you buy books from GPI. We will accept certified checks, money orders, company checks or cash. We will not accept ANY personal checks.

Step 3: Register and pay for your exam on PSI at <https://test-takers.psiexams.com/gaco/test>  
PSI will notify you by email when you can register/schedule.

Step 4: Attend Classes.
