
RESORT VILLAGE OF PASQUA LAKE NEW/SLETTER

Now independent from the Rural Municipality, the Resort Village will operate as an urban municipality under its own elected council, and manage our needs and priorities through our own administration. The resort village stretches along the north side of Pasqua Lake, including all properties on the lake side, and some on the hill side. Tax Enforcement

Any proceedings on properties with tax arrears that started under the rural municipality will continue under the resort village. There will be no interruption on the time lines for tax enforcement on properties with unpaid taxes. Any future action to collect tax arrears will be taken by the RV.

Minister's Order

The Resort Village was created through a Minister's Order that defined the properties included in the Resort Village, and laid out a pathway for the restructuring. Within the order, a number of facets of the community were defined, including:

- the council for the RV will consist of a mayor and three councillors
- the terms of office for the mayor and councillors will continue until the general election in 2028
- a Transition Committee was formed of those elected to the council and an official from the Ministry to facilitate the transition
- RV of Pasqua Lake will function as an urban municipa,liity

Bylaws, Policies and Resolutions

All bylaws and resolutions from the Rural Municipality are still in force. Over the next year, the Resort Village council will pass our own resolutions and adopt our own bylaws to replace them. By the end of 2024, the Resort Village will be governed by a complete set of our own bylaws. The introduction and passage of all bylaws will be announced on agendas and public notices. The guiding bylaws will be available on the website.

Zoning Bylaw and Building Bylaw

In the same way, the Resort Village will be governed by the RM's zoning and building bylaws until council adopts their own. For these planning bylaws, the RM's bylaws will be in effect for up to two years, or until news ones are adopted. The introduction of new zoning bylaws and building bylaws will have public notice and ample advance notice. In the meantime, the guiding zoning and building bylaw and official community plan will be on the website,
